15 16 17	(a) The community redevelopment agency shall be governed by a board of commissioners consisting of the Mayor, the four members of the City Commission and four members of the County Commission.
18 19 20	(b) The Board of County Commissioners of the County shall appoint the four members of the County Commission pursuant to a procedure and for terms chosen and implemented by the Board of County Commissioners of the County.
21 22	(c) The City Commission authorizes the agency to annually designate the chairman and vice-chairman of the agency.
23 24	Section 2. Section 6-53 in the Code of General Ordinances of the City of Tallahassee, Florida, is hereby deleted as follows:
25	Sec. 6-53. — Terms of office.
26 27	The agency commissioners shall have terms which run concurrent with their city and county terms, respectively.

1	Section 3. Conflicts. All ordinances or parts of ordinances in conflict with this ordinance
2	are hereby repealed to the extent of such conflicts, as of the effective date of this ordinance.
3	Section 4. Severability. If any word, phrase, clause, section or portion of this
4	ordinance shall be held invalid or unconstitutional by a court of competent jurisdiction, such
5	portion or words shall be deemed as a separate, distinct and independent provision and such
6	holding shall not affect the validity of the remaining portion of the ordinance.
7	Section 5. Effective Date. This ordinance shall become effective immediately upon
8	its adoption.
