GREATER FRENCHTOWN/SOUTHSIDE (GFS)

Bethel Baptist Church Proposed Affordable Housing



On Thursday, October 17, 2024, the CRA Board unanimously approved Bethel Baptist Church's application for \$400,000 in funding to assist with the environmental, engineering, and

architectural costs for a proposed affordable housing, mixed-use project to be located at 835 W. Tharpe St. The CRA GFS CAC unanimously recommended funding approval with conditions at their Monday, September 9, 2024 meeting. CRA funds are to be disbursed following the issuance of development approvals by the City of Tallahassee Growth Management Department.

The proposed project includes 57 housing units, 6 of which will be affordable housing. The affordable housing units will be subject to restrictive covenants for 7 years to ensure their affordability. The total project cost is estimated at nearly \$18,435,625, including \$1,029,800 for environmental, engineering, and architectural costs. Infrastructure construction is projected by September 2025, and final plat approval is projected for December 2025.

Bethel Baptist Church (property owner) has been established for over 153 years. It has a proven track record of success with development/redevelopment within the Greater Frenchtown District and within the City of Tallahassee. The proposed project is consistent with the GFS Redevelopment Strategic Investment Plan Priority Area 1, which aims to increase economic development; Priority Area 2, which aims to increase the availability of affordable, mixed-income housing; and Priority Area 4, which aims to enhance the beauty and vitality of GFS neighborhoods.

Architectural Consultant Services for 2021 Holton Street

On Thursday, October 17, 2024, the CRA Board unanimously approved the award of a contract to 4M Design Group, PA, for Architectural Consultant Services to the restoration of the Robinson Grocery Store and authorized the CRA Executive Director, or a designee, to negotiate and execute a contract. The architectural team will need to provide construction documents for a contractor to properly restore the building on the CRA-owned property at 2021 Holton Street. The restoration is to include age-appropriate architectural details and finishes, which are a requirement of the \$250,000 state grant from the Division of Historical Resources. A Request for Proposal (RFP-091-24-KM) for an Architectural Services Consultant was advertised.

DOWNTOWN DISTRICT (DT)

Bicentennial Square Park



Thursday, October 17, 2024, the CRA Board voted unanimously to approve funding for Phase 1, not to exceed \$45,000, and for Phase 2, not to exceed \$471,000, for the Bicentennial Square Park concept and to require the design consultant to provide alternatives for the bathroom design and location.

The 2024 KCCI (Knight Creative Communities Institute) Community Catalyst Team has developed a proposal to enhance an underutilized space in Tallahassee's Downtown, next to City Hall, and transform it into a gathering place to be called Bicentennial Square Park. The conversion of this space into a park is a three-phase approach with Phases 1 and 2 consisting of design, engineering, and permitting, along with landscaping, park furnishings, kiosks, signage, and planters. The Downtown Redevelopment Commission (DRC) recommended funding approval with conditions at a special meeting on October 1, 2024.



On Thursday, August 22, 2024, the CRA Board voted unanimously to approve a CRA contribution of \$250,000 for activating exterior spaces as part of the C.K. Steele Plaza Revitalization Project, located at 111 W. Tennessee Street. On August 8, 2024, the Downtown Redevelopment Commission (DRC) discussed the C.K. Steele Revitalization project and recommended that the CRA Board approve the funding request for \$250,000.

This project prioritizes the City's Five-Year Strategic Plan to create a multi-modal transportation hub at C.K. Steele Plaza. The proposed improvements are consistent with the Downtown Community Redevelopment Plan and align to create a vibrant and attractive downtown district for visitors and residents.
