During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communication between the known telephone and telephone number

The defendant started the text message thread with "I need a hhr of top". It should be noted that "top" is street slang for oral sex. This was met with the response "are you affiliated with any type of law enforcement agencies". The defendant was asked whether he wanted a "in call or out call". Based on my training and professional experience, an in call refers to a solicitor traveling to the prostitute and then exchanging money for a sexual act within the confines of the prostitute's hotel room or residence. An out call refers to a prostitute traveling to the defendant's house, motel room, or other predetermined location, where an exchange of currency or other form of payment is exchanged for a sexual act. The defendant replied with "In". The defendant received a response of "Qv70 hh120 hr180 over nite 300". The final price provided for "hhr of top" was "100".

On , the defendant again sent a text message that read "I need a hhr of top". The price of "100" was sent back. The defendant replied with "Ok where r u". It was also determined the defendant wanted a car date. The defendant was then told to call the known telephone number.

On , the defendant sent another text message that read "I need a hhr of top". He received a text message back that read "Ok that's fine 80". He also said he wanted to meet "now". An address known to law enforcement was provided as it was determined the defendant wanted a "car date". In addition, based on this string of text messages it is also possible the defendant followed through with his request as he text "I'm here".

On , the defendant sent a text message asking for a "hhr" and whether Greek was offered. The defendant was asked to clarify his definition of Greek to which he replied "Anal". He received a text back that read "It's extra". The defendant advised he knew and wanted to know the total amount for half an hour. The price of \$180 was provided. He said he would be at the location in 15 minutes.

On , the defendant sent a text message requesting an in call for half an hour. No price was provided. Based on the numerous previous solicitations it is believed this was another attempt at solicitation for prostitution.

Utilizing law enforcement databases, it was determined the telephone number was associated with a Michael Stephen McDonald, Jr (defendant). In addition, the defendant also provided the telephone number during a burglary investigation to Tallahassee Police Department on April 1, 2018 (TPD Case #18-10426).

On August 6, 2019, I called A male answered the telephone on the second call. The person identified themselves as Michael McDonald (defendant). I requested the defendant come to the police department for an interview. He advised he would come to the police department within 30 minutes. He also confirmed should I send something confidential or call the telephone number only he would see the text or receive the phone call.

On the same date, the defendant called back and advised he would not be providing an interview. He advised he would have his attorney reach out to me. As of this writing, I have yet to be contacted by an attorney representing the defendant.

Based on the above facts, it is evident that the phone number was used and is still being used by Michael Stephen McDonald, Jr. As such, it is McDonald solicited a prostitute on by asking for half an hour of oral sex for a price of \$100, on by again asking for half an hour of oral sex for a price of \$100, on asking for half an hour of oral sex for a price of \$80, on by asked for half an hour of anal sex for \$180, and finally on for requesting an "in call". In all, there is probable cause to charge McDonald with five counts of solicitation for prostitution (F.S. 796.07 4a1)

The above probable cause was approved by ASA Lorena Bueno. On August 21, 2019, Judge Richardson signed warrants 2019MM2215A1, 2019MM2215A2, 2019MM2215A3, 2019MM2215A4, 2019MM2215A5 for solicitation for prostitution. This case will be labeled Warrant Issued pending the apprehension of McDonald.

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communications between the known telephone number and telephone number

This was determined to be a Voice over IP (VoIP) telephone number issued through the parent company Pinger, for use with the mobile application TextFree.

Upon review of these communications, I found communication began with a message sent by the suspect reading, "Hi how are you doing? Please contact me. Thanks! :-)" A response was sent to the suspect asking if he was affiliated with law enforcement. The suspect responded, "Not in any way shape or form!!!" The suspect was asked if he was interested in a "car date or out call." The suspect asked what the "donations" were and was told a "Qv" or quick visit (period of time equal to, or less than, 15 minutes) was \$70.00, a half hour was \$120.00, an hour was \$180.00 and an overnight visit was \$350.00. Based on my training and professional experience, I know these times and prices correspond to the amount of time each person is willing to engage in a sexual act, and the prices which will be paid by the suspect. After receiving the time/prices, the suspect asked, "Will you be available later this afternoon?" An affirmation was received by the suspect and he requested photographs be sent.

The suspect received seven photographs, the suspect sent a message reading, "I can't wait. I'm allergic to condoms though." The suspect asked if that was ok, and an affirmation was sent with additional information indicating that would cost more.

As communication continued about where a meeting would take place, the suspect asked, "Are you ok with my giving you the money immediately after we finish?" The suspect asked this multiple time during the communication, and also stated, "The last time I gave the money up front, I was robbed."

Communications appear to have terminated on when an agreement could not be reached as to when payment would be rendered.

The suspect re-initiated contact on though communication was brief and no criminal conduct was observed.

I issued a subpoena to Pinger requesting information related to the customer issued telephone number

between the time of the investigation. Upon receipt of the requested information, I

found the account was associated with . Upon research of that e-mail address, I found it was associated with a male identified as Stelios G Chimonides.

I contacted Chimonides by phone on 08/08/2019 and requested he meet with me for an interview. Chimonides arrived at the Tallahassee Police Department, where I conducted a non-custodial interview, which was recovered on my department issued body-worn camera.

During the interview, Chimonides stated he has used TextFree previously. Chimonides had to look on his cellular phone to get the name of the mobile application. Chimonides provided his TextFree telephone number as . Chimonides stated he used to the mobile application "casually". Chimonides did not recall the suspect phone number used in the above described communications.

Chimonides admitted to communicating with individuals on the specific website where the original advertisement was posted. Chimonides stated he went on the site "just to look." He could not recall how many individuals he has communicated with from the site, though he stated he has never met anyone.

I showed Chimonides the information provided by Pinger showing his work e-mail was verified on the Pinger account. Chimonides initially stated no one else had access to the e-mail account, though then stated it was possible someone else had access. Chimonides could not provide anyone specific who may have had access.

During the course of the investigation, Chimonides volunteered he had previously been arrested for Solicitation for Prostitution. I exited the interview briefly to confirm the arrest on 12/10/2015 (case # 2015MM3674A1) which resulted in pretrial diversion.

Once I returned to the interview, Chimonides stated he didn't understand the point of the interview and further stated he had not done anything wrong. Chimonides denied soliciting another person for sexual acts in exchange for money. Chimonides stated he was not allergic to condoms, though he stated he had medical tape on his arm recently and pointed to an area on his arm, which looked like a bruise, but indicated the are of minor injury was the result of medical tape.

Chimonides again later stated he hadn't done anything wrong and wanted to know what the evidence was. I again showed him the transcript of the texts and began reading. When I read the question about donations, Chimonides acknowledged this question and stated he was simply looking for companionship, not sex. I asked Chimonides if he often asked that question when communicating with individuals on the site and he affirmed. I then read the text from Chimonides reading, "I can't wait. I'm

allergic to condoms though." Chimonides sat back and uttered, "Oh boy" and "I don't know why I said; I mean, I don't know why; if that's me!"

Based on the above detailed investigation, there is a belief Stelios Chimonides, a then 73-year-old male, requested "donations" in exchange for times and was provided with price amounts for differing amounts of time. Based on my training and professional experience, I know these times and prices correspond to the amount of time each person is willing to engage in a sexual act, and the prices which will be paid by the suspect. This is corroborated by the fact Chimonides advised he was allergic to condoms, indicating he would not be able to utilize a condom during the encounter. Though a Notice To Appear (NTA) was initially discussed, Chimonides' repeated assertion he had not done anything wrong indicated to me his criminal behavior likely would not be stopped/corrected by the issuance of an NTA.

The probable cause in this case was reviewed via e-mail by ASA Bueno on 08/08/2019. The following warrant was signed by Judge Smith on 08/09/2019 and entered into JIS the same date: 2019MM2110A1, Procure for Prostitution, bond: \$1,000

I contacted Chimonides' attorney, Mr. Iturralde and made him aware of the warrant. Chimonides turned himself into the Leon County Detention Facility on the same date.

This case is closed, cleared by arrest.

Communication between the known telephone and telephone number

The defendant started the text message thread with "Hey babe are you available". This was met with the response "are you affiliated with any type of law enforcement agencies". The defendant was asked whether he wanted a "car date or out call". Based on my training and professional experience, a car date refers to a solicitor picking up the prostitute and then exchanging money for a sexual act within the confines of the solicitor's vehicle. An out call refers to a prostitute traveling to the defendant's house, motel room, or other predetermined location, where an exchange of currency or other form of payment is exchanged for a sexual act. The defendant sent "Which is cheaper". The response was "Out call" and a price of "65" was provided. The defendant sent "For an hour" to which there was a response of "180" along with "Qv70 hh120 hr180 over nite 300".

On the defendant sent the text message "Hey babe" followed up with "Wanna see if you are available". This was met with the response "How much time do you want". The defendant advised 1 hour. When asked where he was located, the defendant supplied the address of "2377 Tina drive Tallahassee-Florida" The defendant also asked, "How much". He received a text which read "And your ticket is 180". The defendant responded with "Oh no" and "That's a lot byee" He was then provided a price of \$150. The last message from the defendant was "Nope". Due to this, it does not appear the defendant followed through with the aforementioned plans.

On August 12, 2019, I again called . A male answered who confirmed he was Kenneth. The defendant advised he did not come on August 8, 2019 for the interview because he lost the address. I again provided the address, making sure he wrote the address down, and also confirmed he would come to the police department around 2:00 pm. When he failed to show at the time he designated, I called

and spoke with the defendant once again. This time he advised he was in Bainbridge, GA and still had not left. He was unsure what time he would be able to make it to the Police Department. I rescheduled the interview for 8:00 am on August 13, 2019.

At 7:57 am on August 13, 2019, I received a phone call from an attorney who advised they represented the defendant. The attorney explained the defendant would not be making a statement at this time.

Based on the above facts, it is evident that the phone number was used by Kenneth Opoku Anang at the time of the discovered conversations. As such, it is believed Anang solicited a prostitute on by asking the price of an "out call" for an hour and receiving a price of \$180 and again on when texting he wanted an hour, providing his address, and receiving a price of \$180. As such, there is probable cause to charge Kenneth Opoku Anang with two counts of solicitation for prostitution (F.S. 796.07 4a1).

The above probable cause was approved by ASA Lorena Bueno. Warrant numbers 2019MM2199A1 and 2019MM2199A2 were signed on August 20, 2019 by Judge Aikens. This report will be labeled Warrant Issued pending the apprehension of the defendant.

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communication between the known telephone and telephone number

The defendant, believed to be Rashard Swain (defendant), started the communication by calling. There was no answer, but a text message was sent back stating "Watz gud". The defendant wrote back "Tryna see hm". It was also asked that the defendant clarify what "hm" meant. He replied "hm" meant "how much". The response to this was "QV60 hh120 and fa a hour 150". The defendant asked if he could cash app to send the money and when he was told no, he advised he would hit the other subject up another time.

Another conversation occurred between the known telephone number and telephone number

This conversation started with the defendant send the text message "Hm just a BJ (blow job)?" The response back was "Are you affiliated with any type of law enforcement agencies". When asked how long the defendant wanted he replied with "Won't take me long specially if u good 10 min?" Further communication occurred with the defendant offering "50 for 15". He also requested pictures. In all 18 pictures were sent. The defendant also commented on the fact the other person looked like a "lil girl" and also asked how old she was. Ultimately, an address known to law enforcement was supplied. It appears the defendant went to this location as he text "Come outside". The response back was "Kk". This ended the communications.

It was determined the carrier for telephone number was Verizon Wireless. A court order was issued to Verizon Wireless requesting call data information and subscriber information. The information returned failed to yield an identity as it advised Comcast would need to be contacted as the line was leased to them. A subpoena was issued to Comcast requesting the subscriber information.

A subpoena was issued to Pinger, Inc requesting subscriber information for telephone number The information returned identified the registered telephone number as No other identifying information was provided.

Utilizing law enforcement databases, it was determined Rashard Swain was affiliated with telephone number . The last known local address for Swain was identified as 2132 Loyal Lane Apt 4. The address on the FL DL was listed as 236 W 19th St, Jacksonville, FL.

On August 14, 2019, Inv. Osborn and I went to 2132 Loyal Ln Apt 4 in an effort to interview Swain. After several knocks at the door there was no answer. I attempted to call the defendant at the telephone number

several times and even left a voicemail. I also sent a text to the number requesting a call back. I received a text back advising "wrong number". I replied with a text informing the person I was looking for Rashard Swain and believed this was his telephone number. The text back advised it was not Swain's telephone number. The attempts to contact the defendant were captured on my body worn camera.

On August 15, 2019, the requested information from Comcast was received. Rashard Swain was identified as the subscriber for phone number . The address provided with the subscriber information was 2132 Loyal Lane Apt #4.

Contact was made via phone with a number associated with the comcast account requesting Swain call me. Within a couple of minutes, I received a phone call from . The subject identified himself as Swain, but refused to come to the department for an interview.

Based on the above facts, there is probable cause to charge Rashard Swain with one count of Solicitation for Prostitution for sending the text messages using telephone number which had an associated phone number of with the subscriber name Rashard Swain. The text message content included communication concerning the exchange of \$50 for 15 minutes of time while the defendant received oral sex.

On August 15, 2019, ASA Lorena Bueno reviewed and approved the probable cause. Judge Gary signed warrant #2019MM2148A1 on the same date for one count of Solicitation for Prostitution.

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communications between the known telephone and telephone number

The defendant started the communication by attempting to call the known telephone number. He then sent a text which read "Hello!! I saw your ad on stg (skipthegames) and was wondering if you are available? And if so what is the donations for a husband and wife couple at our hotel room foran hour." It should be donations is a common term used in lieu of asking for a price. This was met with the response "are you affiliated with any type of law enforcement agencies". The defendant sent a text message back assuring he was not law enforcement. He then asked "So what would the donations be for us to have you over to our room tonight for an hour or maybe longer?" When he was asked who "our" was, the defendant replied with "Our would be me and wife sweatheart". The defendant also indicated he was staying at a hotel on North Monroe St. The defendant sent a text reading "Donations?" which was followed up with "We got party favors also !!" The defendant received text messages back with prices corresponding with length of times. These were "QV70", "Hh120", "hr180", along with a text message that read "Ok and TBH (to be honest) I only do "qv70 hh hr". It should be noted qv is short for quick visit, hh is short for half an hour, and hr is short for hour. A quick visit is equal to 15 minutes of time or less.

On

the defendant text the known telephone number again asking "What's your donations for m out call". He was asked via text "How much time do u want". The defendant replied with "Id love to c u for an hr but maybe longer. The defendant was supplied a price of \$180 for an hour, 180x2 for 2 hours, and \$470 for overnight. The defendant also asked, "Do u party?" When he was told "Yes", he replied with "Cause I'm really wanting me a girl taht smokes hard ?" When asked if he was talking about weed, the defendant replied with "I'm talking about not the soft but the Hard". It should be noted the defendant is currently bonded out on possession of cocaine charges. Due to this it is believed the defendant was requesting the other party partake in the use of cocaine or another similar illegal drug.

A court order was submitted to the carrier of telephone number . The requested information was provided by Verizon Wireless. This information identified the subscriber as Richard Singletary (defendant). The listed address was 1904 Longview Dr. In addition, the defendant provided the telephone number when he was booked into the Leon County Detention Facility.

On FDLE Special Agent Erica Hindale-Morris and I went to 1904 Longview Dr in an attempt to interview the defendant. Contact could not be made at the residence due to the house being surrounded by a chain link fence which was locked with a heaver chain and lock. There were also two large dogs within the fenced in yard which appeared aggressive. I called and a woman answered. She provided an additional telephone number for the defendant. I called several times and sent a text message requesting

Based on the above facts, it is evident that is utilized by Richard Singletary. As such, there is probable cause to charge the defendant with two counts of solicitation for prostitution (F.S. 796.07 4a1) for requesting a subject travel to his hotel room and partake in sexual acts in exchange for money on

On August 28, 2019, ASA Lorena Bueno approved the above probable cause. On the same date, Judge Richardson signed warrant 2019-MM2282 for solicitation for prostitution. As of this writing, Richard Singlerary is still outstanding. This report will be labeled Warrant Issued- Follow Up Needed pending his apprehension.

The defendant, believed to be Jaylin Buggs (defendant), started the communication by sending the text "Yo". The reply back stated, "Are you affiliated with any type of law enforcement agencies". During this initial text thread, the defendant provided the address 2307 Domingo Dr as the location he wanted to meet the subject. He also requested pictures, of which six were sent. The defendant was asked if he wanted a "qv or hh". Based on my training and professional experience, I know a "qv" is a quick visit which is typically 15 minutes or less of time and a "hh" is a half hour of time, both during which a sexual act is performed in exchange for currency. The defendant text back "Jus a quick one". When the subject arrived, the defendant text "I'm looking right at you" and "Grey truck right?". In addition, he text "Pull out that yard". This conversation terminated after the defendant text "You not tryna go to a bathroom?" and then receiving the text back "Na Mann I'm gud boo u played hit my line wen u get yo mf life together".

On , the defendant again text "Yo". The response sent back was "Wasssssup". The defendant asked "Available" and received a response of "Yes". The defendant asked "You do anal?" He received a price of \$140. The defendant then sent a text reading "Damn only have 20" and "I can do 40". It was determined the defendant would receive a quickie for \$40. An address known to law enforcement was provided. The defendant requested pictures be sent to him. Eight pictures were sent. The defendant next text "any ass pics?" The defendant then received six additional pictures.

Utilizing law enforcement databases, I located a traffic stop performed by Tallahassee Police on February 11, 2019 during which Jaylin Buggs supplied phone number as a contact number.

On August 15, 2019, FDLE Special Agent Erica Hindale-Morris and I went to 402 Glades Rd, Havana in an effort to locate the defendant for an interview. This was the address provided during the February 2019 traffic stop along with the address on the defendant's FL DL. He was not home; however, his grandfather provided the phone number as a way to contact him. In addition, another family member present called the defendant's mother. I spoke with her briefly via phone. During the conversation she also provided phone number for the defendant.

Prior to being able to call the defendant he called me from . I requested he meet me for an interview. Initially he said he would, but he was currently busy. After several more phone calls (all of which were from , the defendant advised he would have his public defender contact me. Several minutes after this phone call, the defendant called again requesting to meet at San Luis Park for an interview.

SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT:

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communications between the known telephone number and telephone number observed a message from the suspect asking, "U in tally?" The suspect then asked, "how many (unknown emojis) for you to come see me?" The suspect was asked for a location and how much time he wanted. A response was sent by the suspect reading, "Behind wing stop off w. Tennessee st" and indicated he wanted 30 minutes of time. The suspect indicated he had "60" followed by a message stating he could go to the store and also asked about "rates." A response was sent reading, "I can give u a qv fa 60."

The suspect was identified as Mackenzie Cesar via the telephone number used for the above communications. I determined Cesar had utilities at 2020 Continental Ave. #240. Telephone number was the telephone number listed on the account. Inv. Ray and I attempted contact with Ceaser at the residence on 08/26/2019, though there was no answer at the door. I called telephone number and a male answered. I asked for Cesar by name. The male identified himself as Cesar and I requested to meet with him for an interview. Cesar stated he was not in town and I stated I would contact him the following week to schedule an interview. Since that time, Cesar has not answered any calls or text messages. I noticed Cesar had a shirt with a logo for "Healthy Kids". Inv. Ray subsequently attempted to contact Cesar at the business but were told he no longer worked at the location and had moved. I also discovered a new utility account was opened at the residence in a new name, and Cesar updated the address on his driver's license to 8325 Bay Pointe Dr. #604 in Tampa, FL.

Based on the above detailed investigation, it was determined Cesar committed the offense of Solicitation for Prostitution on by engaging in communication of paying for a period of time related to an individual being advertised on a site with multiple sexual acts.

The below probable cause was approved by Sgt. Bush and ASA Lorena Bueno. Judge A. Miller signed warrant #2019MM2346A1 for one count of Solicitation for Prostitution.

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communication between the known telephone and telephone number

The defendant started the text message thread by sending a text message thread which read "Hey what's up? What are your rates?" This was met with the response "are you affiliated with any type of law enforcement agencies". Once the defendant advised he wasn't, he was asked via text message "...how much time do u want (qv70 hh120 hr180" and "incall outcall or car date". Based on my training and professional experience, I know that the first text message sent refers to increments of time and the price relative to the increment of time. A QV is a quick visit or 15 minutes of time or less. HH is a half an hour. Hr is an hour. In call, out call, and car date are all types of known names of appoints between prostitutes and solicitors. An in call refers to the solicitor coming to the prostitute's location, an out call refers to the prostitute coming to the solicitor's location, and a car date is when the prostitute and solicitor meet in a vehicle. During each, a form of payment is exchanged for a sexual act. The defendant was next asked how much time he wanted. He replied with "Qv".

A court order was obtained demanding the cell phone carrier for telephone number provide subscriber information. Based on the supplied information, the owner of the telephone number was determined to be Alexander Simmons (defendant).

On August 28, 2019, I called and spoke with a male subject who identified themselves as Alexander Simmons (defendant). He advised he was no longer in Tallahassee, FL, but refused to provide his exact location other than he was about two hours away. I then had the defendant verify his date of birth and the last four of his social security number which matched the information in the DHSMV database. I confirmed the telephone number was his telephone number. He also confirmed he had this telephone number in The defendant did acknowledge he had let other people use this telephone though. According to the defendant, he allowed coworkers at Tallahassee Dodge Chrysler Jeep to use the phone periodically when he worked there during the above mentioned time frame. When confronted with the fact the text messages content led me to believe he was soliciting a prostitute, the defendant advised it was common for he and his coworkers to look at skipthegames and then text women who advertised on the site. He could not recall whether he specifically text anyone. He advised he could have been at work on the date in question as he typically worked 12 hour shifts and worked 8:00 am until 8:00 pm.

On August, 29, 2019, I spoke with Debra Hevener, the Human Resources Director for Tallahassee Dodge Chrysler Jeep. Hevener was able to supply the time card for the defendant for Based on the time card, the defendant clocked into work at 8:23 am and clocked out at 5:58 pm. It should be noted the conversation in which he solicited a prostitute occurred

Based on these times, it is highly unlikely the defendant would have been present with coworkers and still at his job as he had already clocked out. This is in direct contrast to his alibi of being at work and coworkers using his telephone.

Based on the above facts, there is probable cause to charge Alexander Simmons (defendant) with one count of solicitation for prostitution (F.S. 796.07 4a1) for requesting an in call quick visit for \$70.

This report will be labeled Warrant Issued pending the apprehension of Simmons.

Prior to beginning the interview, I advised Monroe of Miranda, which he verbally acknowledged. Post Miranda, Monroe admitted to going onto the specific site used for this advertisement and communicating with individuals. Monroe was shown the text messages and stated he had several phone numbers during this time, though he did not specifically recognize this telephone number as his own. Monroe stated he did not pay for a hotel room during the time of Hurricane Michael. Monroe stated he was working at a hotel during that time, though he stayed home because power was out at the hotel.

Based on the fact the suspect communicated in relation to an advertisement for multiple specific acts and was provided with a price of \$130.00, the suspect committed the offense of Solicitation for Prostitution.

The probable cause in this case was reviewed by ASA Bueno via email.

The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communications between the known telephone number and telephone number

I found contact was initiated by the suspect via a phone call which was not answered. Upon being asked how much time he wanted, the suspect he wanted an hour of time. Upon being asked how much he was willing to spend, the suspect responded, "As much as you want I'm down fa whateva." The suspect was provided with a price of \$180.00. The suspect also sent a message reading, "We can do xxtra it's on you."

On , the suspect sent a message reading, "Looking fa an early morning." Upon being asked how much time he wanted, the suspect responded, "Let's do a 30 to 30 min range just want that little time incredible" followed by, "want to get dirty no limits so the price don't matter." The suspect was provided a price of \$140.00. In response, the suspect sent a message reading, "Creampie, cim deep kissing I really want all, might turn out more time needed let me know if u need clean health proof." The term "cim" is short for "cum in mouth" which indicates the suspect wanted to ejaculate into the mouth.

The suspect was identified as Thomas Shuler based on the telephone number used for the above communications. I responded to 2662 Faversham Dr. on 09/09/2019. The door was answered by a female who stated she was the mother of Shuler. She stated Shuler had moved to Orlando or Tampa and had no plans to return to Tallahassee to her knowledge. She further confirmed the telephone number used for the above communications belonged to her son. My contact at the residence was recorded via my department issued body worn camera.

I returned to my vehicle and called the number listed above. A male answered and identified himself as Thomas Shuler. Biographical information was provided as proof of identity. The call was recorded via my body worn camera as it as on speaker phone. Shuler admitted to going onto sites which identified individuals for sexual purposes, though he stated he no longer does so after getting engaged to be married. Though he was unable to recall the specific communication, he admitted it was likely him engaged in the communications.

Based on the above detailed investigation, it was determined Shuler committed the offense of Solicitation for Prostitution on . Shuler was previously adjudicated guilty of the same offense on 03/21/2000 (2000MM2064A1) making each of the above offenses a 1st degree Misdemeanor.

The below probable cause was approved by Sgt. Bush and ASA Lorena Bueno. Warrant # 2019MM2596A1 was signed by Judge L. Smith on October 1, 2019 for one count of Solicitation for Prostitution.

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communication between the known telephone and telephone number

The beginning of the conversation began with the defendant sending a text which read "Ello doll you working?" He was then asked twice "Are you affiliated with any type of law enforcement agencies?" After he said he wasn't he was asked how much time he wanted. He replied 15, which this investigator knows to mean 15 minutes of time or a "quick visit". He was also asked if he wanted "incall or outcall". The defendant advised "in". Based on my training and experience, I know an "incall" refers to a solicitor travelling to the prostitute's location. Conversely, an "outcall" refers to the prostitute travelling to the solicitor's location. During both, a sex act is exchange for currency.

The defendant was asked how much he wanted to spend for the "quick visit". The defendant requested "lollipop land" which was later clarified to mean oral sex. The defendant also advised he wanted the oral sex with no condom. He was provided an address known to law enforcement; however, when it was time for the defendant to come, he advised he couldn't because his motorcycle was dead. The defendant also advised he was in Panacea.

Utilizing law enforcement databases, I determined telephone number belonged to Matthew Trenary (defendant). I contacted the defendant on A male answered the phone and identified themselves as the defendant. I requested they come to the police department for an interview. He advised he was a truck driver and did not know when he would be back in Florida. I confirmed his identity by verifying his date of birth and the last four of his social security number. After confirming this biographical information, I began to ask the defendant questions pertaining to the case.

The defendant acknowledged he knew about the website where the original advertisement was posted. He alleged he knew about the website because he had a friend who posted advertisements on it. He claimed he had in fact visited the site to look for her when she has gone missing in the past. The defendant confirmed he has had the telephone number for a long time, specifically way more than a year. He denied ever communicating with anyone who posted on the website, other than his friend. He also denied requesting oral sex and stated he wouldn't use terminology such as blowjob or lollipop land. The defendant claimed if he wanted to pay for sex, he would just call his friend who posted on the website.

Ultimately, the defendant claimed his telephone number was "spoofed". Spoofing occurs when someone uses technology to send a text message or make a phone call utilizing their device but having it portray another telephone number. He claimed to have had this happen to him on other occasions. The interview was audio recorded.

A court order was obtained for the telephone number . An analysis of the returned records shows the device sent numerous text messages to the known telephone number. In addition, there voice calls were consistent throughout the time period. Should the telephone number have been spoofed when the text messages were sent, they would not appear on the call data report as they wouldn't have originated from the defendant's device.

A search of FL DHMSV records shows the defendant has an address associated with Panacea, FL. He also has two motorcycles registered to him. This is consistent with the information supplied in the text message thread.

Based on the above facts, there is probable cause to charge the defendant with one count of Solicitation for Prostitution (F.S. 796.07 4A1) for requesting a quick visit in exchange for \$80 during which he would receive oral sex.

This report will be labeled Warrant Issued pending the arrest of Matthew Trenary.

SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT:

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communications between the known telephone number and telephone number

Upon review of the recovered communications with telephone number , I found the first message was sent by the suspect on asking about availability. The suspect asked, "How much for a hh". The use of "hh" was short for a half hour of time. The suspect was provided with a price of \$100.00. The suspect then asked about the price for a "q.v." which is short for "quick visit." This is a term used for a period of time equal to, or less than, 15 minutes. As communications continued into , the suspect asked, "What a price we can lock in at? I fuck really really good." The suspect also sent a message reading, "I work a lot a lot, I be needing that stress reliever. You do anything bare?" The use of "bare" is a slang term for sexual intercourse without a condom. The final text response was from the suspect reading, "That 320 number is me" indicating he had sent communication from another number which included "320."

Upon review of communications with telephone number , I found the first recovered message was sent by the suspect on 1 asking about availability. The suspect asked for a half hour of time by use of the term "Hh" and was given a price of \$120.00. The suspect then asked about the price for a quick visit and was told \$70.00.

On , the suspect sent a message reading, "50 for qv?"

The suspect in this case was identified as Aaron M Davis based on telephone number of which was used for direct communication in October of 2018 and was associated with the e-mail address used to set up the VoIP number used for communication in July of 2018. Phone records received in this investigation showed telephone number was issued to Tammee Davis at 8201 Little Terry Rd. in Tallahassee. A search of the Florida driver's license database showed a driver's license issued to Aaron Davis with an address of 8201 Little Terry Rd. in Tallahassee. Davis provided his birth certificate to the Department of Highway

The suspect again initiated contact on and asked, "40 hh?"

On the suspect sent a message reading, "You trying to make 40 tonight ?"

The suspect was tentatively identified as Alphonso Toliver, Jr. based on the telephone number used for the above communications. Toliver made a report with the Tallahassee Police Department in early 2019 where the telephone number was listed as his own with an address of 1600 Old Bainbridge Rd.

I contacted Toliver by phone to request an interview on 09/06/2019. Toliver stated he was no longer in Tallahassee and was now in Jacksonville, FL. I discussed possibly traveling to Jacksonville to interview Toliver. A short time later, Toliver called back and identified himself by name. He indicated he was driving from Jacksonville and wished to conduct an interview at TPD that afternoon. I then received a call from attorney Gannon Coens, who stated he would be representing Toliver in this investigation and Toliver would not be making a statement or consenting to an interview.

Based on the above detailed investigation, it was determined Alphonso Toliver, committed the offense of Solicitation for Prostitution by endeavoring to engage in sexual acts in exchange for money on the dates of

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communication between the known telephone and telephone number

The beginning of the conversation began with the defendant being sent an address known to law enforcement. This address corresponds with the address for the original poster of the sexually explicit advertisement. It is believed there was voice communication between the defendant and the poster of the advertisement prior to the initial text message being sent. The defendant replied, "I only got 50 and u live far". He also sent "Can i pay for cell bill". He was told that \$50 plus payment of the cell phone bill would be sufficient. Approximately two hours later, the defendant text "U at the spot". He also attempted to call the known telephone number twice with both calls showing missed. He then text "Here".

An hour and a half after the defendant text "Here", he received a text message reading "Wasssssaup". He replied, "I had come by". Ultimately, the defendant was told he could come back; however, it unknown whether he actually did.

Utilizing law enforcement databases, it was determined belonged to Alex Soler (defendant). These included a stolen vehicle report where the defendant provided the phone number to Tallahassee Police Department (2018-00005103). It should be noted a court order for subscriber information is still forthcoming.

On September 9, 2019, I contacted the defendant via telephone number . I requested he come to the police department for an interview. The defendant advised he was in class in Tallahassee, but he would be done within the hour. He agreed to come to the police department the next morning around 8:00 am.

On the same date about 30 minutes later, the defendant again contacted me from confirming the time and location he needed to come to for the interview. He confirmed he would come to the police department for the interview.

On September 10, 2019, the defendant contacted me via the same telephone number and advised he wouldn't be coming to the police department unless details regarding the case would be provided to him. He also advised he sought legal representation but said he would be in contact with me by the end of the same week in an effort to schedule an interview with his legal representation.

Later in the week, I was contacted by Attorney Donald Pumphrey who requested information regarding the defendant. I provided him with the same information I previously provided the defendant. He advised he

would be in contact with me regarding an interview. After several days, I contacted Attorney Pumphrey. He advised he had not been retained by the defendant and that I could interview him without him being present.

On September 23, 2019, I again called several times in an attempt to interview the defendant. The defendant did not answer the phone calls. A voicemail was left requesting he contact me. As of this writing I have not heard from the defendant. In addition, I have no known local address for the defendant where I could attempt contact.

Based on the above facts, there is probable cause to charge the defendant, Alex Soler, with one count of Solicitation for Prostitution (F.S. 796.07 4a1) for responding to a sexually explicit advertisement and telling the advertisement's poster he would pay her phone bill plus \$50. In fact, there is evidence to support the defendant actually traveling to the poster's location and it is possible they met. As of this writing, all attempts to interview the defendant have been futile.

On September 26, 2019, Judge Smith signed a warrant for one count of Solicitation for Prostitution (F.S. 796.07 4A1) for Alex Soler. The probable cause submitted was approved by ASA Bueno. As of this writing Soler has not been apprehended. This case will remain Active pending Soler's apprehension.

SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT:

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communications between the known telephone number and telephone number Upon review of these communications, I found the suspect sent a message reading, "What up girl you shave ur pussy? Hmu if you dont." The suspect was asked how much he wanted and responded, "1 hr send me a pic of your pussy so I know its harry." The suspect also asked, "Can I go raw and bust in you?" The suspect was told, "Its extra for that." The suspect inquired if payment could be accepted via a payment application.

The suspect was identified as Christian Machin based on the number used for communication. Phone records were received, which showed the account was issued to Christian Machin with an address of 1184 Conservancy Dr. W in Tallahassee with a service start date of 02/13/2016.

On 09/24/2019, Inv. Ray and I attempted contact with Machin at his listed address, though there was no answer at the door. On the morning of 06/26/2019, Inv. Ray and I returned to the address and made contact with a female who identified herself as Machin's grandmother. She advised Machin had moved to Sarasota, FL.

A short time after I returned to the Tallahassee Police Department, I was forwarded a call by the Consolidated Dispatch Agency (CDA) advising Machin was attempting to speak with me. I briefly spoke with Machin by phone and it was agreed I would attempt to identify a way to video chat to conduct the interview. Machin provided his telephone number as Machin called back a short time later and stated he

I was unable to conduct the interview via video chat; therefore, I called back and spoke with Machin about the case over the phone. Machin provided biographical information as proof of identity and stated he had telephone number at the time of the communication and advised he had communicated with individuals on the specific site where the advertisement in this case was posted. I read the message of, "me a pic of your pussy so I know its harry" and he acknowledged that was something he sent.

Based on the above detailed investigation, it was determined Christian Machin did offer, or agree to receive, any person for the purpose of prostitution, lewdness, or assignation by requesting specific acts, receiving information the specific act would "cost more" and by subsequently seeking a manner of electronic payment.

The following warrant was signed for the arrest of Machin: 2019MM2568A1, Solicitation for Prostitution, bond: ROR

I contacted Machin by phone and advised him to turn himself in.

SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT:

During the course of an investigation of social media communications, communications by Devin Faulk were recovered. In those communications Anderson solicited sex acts for money.

A social media account with the name of communicated with another social media account known to law enforcement. During communications on , the suspect sent a message reading, "Hey beautiful." After receiving a message reading, "Do i no u" the suspect responded, "Nun chilling my name is Devin I just wanted to let you kno that you are so beautiful." The suspect then asked, "Wanna link babygirl?" As communications continued, the suspect stated, "Lol babygirl um trynna beat ya lil bike inn" and was asked if he had money. The suspect again stated he wanted to "beat ya lil bike in and eat ya pussy up babygirl".

On the suspect sent a message reading, "Wydn" and received a response of, "Tyrna make some money." The suspect responded, "I ain't got nun rn but 7 funky ass dollars u can have emm ion need emmm." The suspect received a response reading, "Ok but im not finna fucc u fa no \$7." The suspect responded, "Duh tf and I wasn't trying to fucc."

On , the suspect sent a message reading, "Wassup Wydn I got 20." The suspect provided his location of Savanah Crossing, a townhome complex in the city limits of Tallahassee, and asked, "what we gone do." The suspect was asked, "How long before you get here" and responded, "You can't come over here I'll give you 40." Upon receiving affirmation of travel to his location, the suspect asked, "We're we gone fuck at." He then stated he had a "spot" behind his apartment. The suspect also inquired why he could not "fucc" from behind.

The suspect in this case was identified as Devin Faulk, a then 19-year-old male based on the content of his social media page. Faulk is known to reside at 2738 W Tharpe St. #1203 (Savanah Crossing). A search warrant was obtained for the social media account, which showed a verified phone number of

, which is linked to Faulk in the Tallahassee Police Department records database. Additionally, there were multiple images within the account which showed a male who appeared to be Faulk, one of which showed Faulk holding what appeared to be a firearm.

Inv. B Bascom attempted contact with Faulk at his residence on 10/25/2019. Upon contact with Faulk's brother at the front door, it was learned Faulk was taking the trash to a nearby dumpster and he fled on foot between buildings. As Inv. Bascom talked to Faulk's brother, the brother pointed out Faulk was attempting to surreptitiously observe their interaction from behind a building approx. 50 yards away. Faulk's brother called out to him to come back and Faulk fled. Faulk's brother then got in a vehicle to retrieve him, though he returned saying Faulk would not get in the car.

On 11/7/2019, I returned to the residence after learning Faulk had warrants issued for hi arrest on 11/4/2019, including one for Failure to Appear on a burglary. I spoke with Faulk's mother, who stated he was not present. I conducted a search of the residence based on the felony warrant and the belief the location was Faulks primary residence. I did not locate Faulk inside

On 11/08/2019, I became aware Faulk had been arrested on the outstanding warrants. Inv. Ray and I met with Faulk at the Leon County Jail. Prior to conducting an interview, which was recorded on our department issued body-worn cameras, I advised Faulk of Miranda, which he acknowledged verbally and agreed to speak with me further. Post Miranda, Faulk stated he had not been on social media in a while, but when I stated the displayed name, he stated it sounded correct. When I discussed specific parts of the communications above, Faulk did not deny he was the person communicating.

Based on the above detailed investigation, it was determined Devin Faulk offered to pay \$20.00, then \$40.00 to engage in sexual intercourse behind his apartment located at 2738 W Tharpe St. on

The following warrant was issued on 11/15/2019: 2019MM3008A1, Solicitation for Prostitution, bond: \$1,000

Faulk was processed at the jail by the Leon County Sheriff's Office on the same date. This case is closed, cleared by arrest.

The following probable cause was approved by Sgt. Bush and ASA Lorena Bueno. Warrant 2019MM3129 was signed by Judge N. Richardson on December 2, 2019. As of this writing, McCray has not been picked up yet. This report will be labeled Warrant Issued- Follow-up needed pending McCray's arrest.

Probable Cause-

During the course of a Tallahassee Police Department investigation, communications were recovered from a telephone number displayed on an advertisement on a website known to advertise for sexual services. The original advertisement was reviewed during the course of the investigation, and multiple sexual acts were advertised.

Communications between the known telephone and telephone number

The defendant started the communication by sending a text message which read "Hey are u available". The defendant was asked whether he was affiliated with any type of law enforcement agencies. He advised he was not. He was asked "how much time" he wanted. He replied, "a qv (quick visit)". He was also asked if he wanted an "incall or outcall". He advised he wanted an outcall. Based on my training and professional experience, quick visit, in call, and out call are all terms associated with prostitution activity. A quick visit is 15 minutes of time or less. A in call is when the solicitor comes to the prostitute's location and an out call is when the prostitute goes to the solicitor's location. During all of these a sexual act will occur in exchange for payment. When asked how much he wanted to spend, the defendant responded with "Not much just want a qv". The defendant also texted "Honestly I am a truck driver almost in Tallahassee was gonna see if you could meet me somewhere" As the text conversation continued, it was agreed the defendant would come to the Walmart on N. Monroe St and would pay approximately \$40.

Utilizing law enforcement databases, I determined telephone number most likely belonged to a Ricky McCray (defendant). McCray resides in Ozark, AL and works in Dothan, AL as a truck driver.

On November 26, 2019, Inv. Osborn and I traveled to Dothan, AL where mutual aid was enacted with the Dothan Police Department. We located the defendant at his work, Sabel Steel (1968 Taylor Rd, Dothan, AL). A consensual interview was conducted which was audio/ video recorded with my department issued body worn camera.

I verified the defendant's identity via his AL DL. He confirmed the telephone number was a previous telephone number he had. He advised he got a new telephone number around November 2018. He also confirmed he was familiar with the website where the original advertisement was posted. The defendant acknowledged the website was advertised prostitution activity. I showed the defendant a copy of the advertisement. He admitted to having seen the advertisement before. He also said he was a "long haul" truck driver at the time the communication occurred. I showed the defendant a copy of the text communications. He confirmed he sent the communication but advised he didn't follow through with the

messages because he thought he was being set up for a robbery. He also confirmed the definitions of a out call and quick visit.

It should be noted that during interview I told the defendant the statute of limitations had expired on the solicitation charge, but that the communication was illegal. During the interview, the defendant offered that he was previously arrested by Dothan Police Department for solicitation for prostitution. At the time I told the defendant the statute of limitations had expired I was not aware of this arrest.

On November 27, 2019, I reviewed the defendant's criminal history. On May 25, 2017, the defendant was arrested by Dothan Police Department for Promoting Prostitution (Dothan PD Case #17-12063). He was convicted (adjudicated guilty) on July 31, 2017 for Promoting Prostitution.

Based on the above facts, it is evident there is probable cause to charge Ricky McCray (defendant) with one count of solicitation for prostitution- 2nd offense (F.S. 796.07 4a2) for requesting a subject to meet him on [:]or a "quick visit" where a sex act would occur in exchange for money and having been previously adjudicated guilty of the same crime.

On December 19, 2019, the following probable cause was reviewed and approved by Sgt. Bush #252 and ASA Lorena Bueno. On the same date Judge Miller signed warrant 2019MM3255 for one count of Soliciation for Prostitution.

Probable Cause

During the course of an investigation of social media communications, communications by Elijah Pittman (defendant) were recovered. In those communications Pittman solicited sex acts in exchange for money.

A social media account with the name communicated with another social media account known to law enforcement. During the communications on , the suspect sent a message which read "what you tryna do". The response back was "U tell me". The suspect wrote back "Fuck". He was asked if he had \$35. The suspect then asked back "I get head too". He was sent a thumbs up "sticker". The conversation continued with the suspect asking where the sex act would take place.

The suspect in this case was identified as Elijah Pittman, a then 19-year-old male based on the content of his social media page. A search warrant was obtained for the social media account

In addition, a verified cell number of was located. Using law enforcement databases, this telephone number was also found to be associated with the suspect. I also compared numerous images found in the social media account to the FL ID pictured of the suspect. I determined they were one in the same.

On December 18, 2019, I attempted to locate the suspect at a known residence on Shelfer Rd. There was no one home at the time. I called but received a message it was no longer active. I also called , another phone number associated with the suspect. A female answered the phone and identified themselves as the suspect's mother. I requested they relay a message to the suspect and have them call me. During the conversation, the female abruptly hung up. I sent a follow-up text message explaining the importance of my interview with the suspect. The response back was in essence for me to do my work and find the suspect myself. She also requested for me to stop contacting her. As of this writing, the suspect has not reached out to me and I am unable to locate him.

Based on the above facts, there is probable cause to charge Elijah Pittman with one count of Solicitation for Prostitution (F.S. 796.07 4a1) for requesting to have sex with someone in exchange for \$35.
