On Wednesday, May 27, 2020, I responded to 2502 Holton Street in reference to an Officer Involved Shooting Tallahassee Police Department (TPD) case #20-83393.

Shortly after arriving at 2502 Holton Street, I was requested by Investigator (Inv.) Nick Roberts #791 to respond to 2505 Holton Street (New St. Johns AME Church) to make contact with Officer Trent Roberts #651 and <sup>2020-CA-1011</sup> Inv. Roberts requested I check with Officer Trent Roberts and enquire whether he made physical contact with the suspect (Natosha "Tony" McDade) AT 2502 Holton Street. Officer Trent Roberts advised me he didn't make physical contact with McDade, so I advised the Officers to respond with their escorts Officers to TPD and make contact with Inv. Sherrie Bennett #714.

Once the Officers were in route to TPD, I was then requested to respond to 2261 Saxon Street, related to a stabbing incident (20-83392) which appeared to be connected to TPD case #20-83393. The residence located at 2261 Saxon Street was located at the intersection of Saxon Street and Tucker Street. The residence faced north toward Tucker Street, with a chain length fence between the 2261 Saxon Street structure and Saxon Street. In front of the residence, across Tucker Street (northside) was Bond Elementary School.

The residence is a single building structure which is divided up into three (3) apartments. The apartments are identified as apartments 1, 2, and 3, with apartment 1 being located on the west end of the structure nearest to Saxon Street. The building is tan in color with white doors and there is a sign at the northwest corner of the driveway and located at the fence line which notes "2261" in black letters on a tan background.

Upon arrival, Officer Mauricio Endara #766 was securing an empty lot located on Saxon Street which was located just behind the residence of 2254 Tucker Street. The address for the empty lot was verified through the Leon County Property Appraiser's Office's website as 2260 Saxon Street. Officer Endara advised me the victim, later identified as Malik Jackson, was located in the empty lot and that was the location he was transported to the hospital via EMS. Officer Endara directed me to 2261 Saxon Street, where Officer Rob Bascom #518 was securing the crime scene, which was a vehicle.

When I made contact with Officer Bascom, he advised me the crime scene was located inside of a silver Hyundai Santa Fe with Florida tag #IP97GZ attached. The tag was registered to Malik Shakur Jackson DOB 10/29/1998, who resides at 2261 Saxon Street Apartment #2. The vehicle was marked off with Crime Scene tape, and was located in the western most parking spot for the three apartments. The vehicle was parked with the front of the vehicle directed toward the apartments, or south. Officer Bascom advised me there was blood on the passenger's side window on the interior, and there was a knife blade located on the pavement just below the front passenger's door.

After being briefed by Officer Endara and Officer Bascom, I made contact with Jerry Nixon who resides in apartment #1. I introduced myself to Mr. Nixon, and he stated, "my son, he saw everything." Mr. Nixon advised me his son, Jaheim Nixon DOB 09/30/2001 was a witness, and what he (Mr. Nixon) saw was the victim (Malik Jackson) run across the street and fall. Mr. Nixon stated "they said" the guy walked down the street, came back, put his mask on, put his hoodie on and stabbed Malik. Mr. Nixon and his wife began to try and contact Jaheim to get him back to the residence so I could interview him. Mr. Nixon didn't know where Jaheim went to. Mr. Nixon's wife told Mr. Nixon "they" went "down there" and pointed toward 2502 Holton Street.

Mr. Nixon stated when he became aware something had happened, Malik was outside of the vehicle and he (Malik) ran across the street and collapsed. Mr. Nixon was pointing toward 2260 Saxon Street when telling me where Malik fell. I asked Mr. Nixon where Jaheim was when the altercation occurred, and Mr. Nixon stated Jaheim was in the car with Malik. Mr. Nixon stated one of his daughters ran into the house and said Malik had been stabbed. Mr. Nixon saw Malik and saw the suspect running and the suspect was dressed in a black hoodie. Mr. Nixon saw the suspect running south on Saxon Street from his residence wearing the hoodie and a mask. I asked Ms. Nixon if he knew who the suspect was, and he stated yeah and pointed at apartment #3. Mr. Nixon went from using the pronoun "him" to "her" at this point and advised he (Mr. Nixon) knew the suspect as "Tony."

Mr. Nixon advised me Tony walked into apartment #2 yesterday, and Malik told Tony not to come in his mother's house "like she owned the house." Mr. Nixon stated "they been having problems with this girl since they moved in." Mr. Nixon stated Tony likes Malik's mother (Jennifer Jackson). Mr. Nixon stated Jennifer told Tony "I don't go that way" meaning she (Jennifer) wasn't homosexual. I asked Mr. Nixon if Tony looked

masculine and Mr. Nixon stated "yeah, she has like a bald head." Mr. Nixon also stated his son took the knife away, but Mr. Nixon didn't know where the knife or his son was located.

While speaking to Mr. Nixon, Eddie Williams with TPD's Forensic Unit arrived. I advised Forensic Tech Williams, Inv. Dan Copelin #643 was in route as the lead Homicide Investigator and Inv. Copelin may have additional instructions. I explained where the two crime scenes were located and the possible evidence to Forensic Tech Williams. The evidence I was aware at this point, was the knife blade, the blood inside the vehicle, and any blood droplets between the vehicle and the empty lot on Saxon Street.

While speaking with Forensic Tech Williams, Mr. Nixon's daughter, Ashanti L. Nixon, DOB 11/02/2001, returned to the apartment along with her sister, Brianna M. Nixon, DOB 09/26/2005. I introduced myself to Ashanti and asked her to speak with me about what happened. I asked Ashanti where her brother (Jaheim) was located in the vehicle with Malik, and Ashanti advised me Brianna was in the front passenger seat, Jaheim was in the back seat behind the front passenger, and she (Ashanti) was in the back seat behind the front passenger, and she (Ashanti) was in the back seat behind the driver. Ashanti advised me they were sitting in the car like they always do and had been "chilling" for maybe 30 minutes to an hour. At this point, Ashanti started talking about an altercation that occurred last night. I asked if the altercation involved Malik, and Ashanti stated, "no, between my Aunt Jen and the lady that stabbed him (Malik)." Ashanti knew "the lady" as Tony, and when I asked where Tony lived, Ashanti pointed at apartment #3. I asked Ashanti if the lady that lived in apartment #3 was the person, she saw that stab Malik, and she stated "yes." I asked Ashanti what happened today, and Ashanti said the doors were locked so they were confused how the door was opened by the suspect. Ashanti advised me Tony opened the driver's door and started stabbing Malik. I asked Ashanti if she saw where Tony went, and Ashanti stated "everybody was fight" trying to help Malik. Ashanti stated Malik didn't have any way to protect himself, and she was just stabbing him.

I asked Ashanti if Malik got out and tried to chase Tony, and she said no, he ran over there to that area as she pointed at the empty lot, where Malik was transported by EMS to the hospital from. Ashanti stated Malik said he was tired, and Malik said he was focused on trying to breath. I asked Ashanti where Tony went, and Ashanti stated she ran that way, as she pointed south on Saxon Street, and Ashanti said she cut over that way, pointing west toward 2502 Holton Street. Ashanti stated Tony yelled "I'm going to finish all ya'll, I'm going to kill all ya'll," as she ran.

I asked Ashanti about the altercation last night, and Ashanti stated Tony and Jennifer were "fussing." Ashanti further stated Jennifer told Tony to get out of her house, and Tony wouldn't leave so Malik told Tony "please leave out of my mom's house." According to Ashanti, Malik asked Tony nicely to leave his mother's home,

and Tony tried to fight Malik at that time. I asked Ashanti if she saw Tony with a handgun last night, and Ashanti stated "yes." Ashanti described the handgun as being small and silver in color. Ashanti stated TPD was called last night, and Tony left, and then TPD was called again when Tony came back. Ashanti also stated Jennifer (her aunt) wasn't there when the stabbing occurred today.

I then made contact with Brianna and verified she was in the front passenger's seat with Malik. I asked Brianna if she was there last night when the altercation occurred, and she advised me she was. Brianna stated she (Tony) was talking to her auntie (Jennifer Jackson) and Tony told Jennifer, she was going to kill her. Brianna advised me Tony was a female who "looks like a man" and she (Tony) lived in apartment #3.

I asked Brianna if she knew why Tony wanted to kill Jennifer, and Brianna said she (Tony) was in love with Jennifer. Brianna stated she's (Tony) "crazy." Brianna stated Tony told Jennifer at some point she (Tony) would kill her (Jennifer) if Jennifer tried to leave her. I asked Brianna if Tony and Jennifer were in a relationship, and Brianna stated "no" they were more like friends, but Tony thought there was more. Brianna stated Jennifer told Tony they weren't together; they were just friends. Brianna continued on to state Malik made Tony to leave his mother's house last night. Brianna said all Malik told Tony was "can you leave momma's house." Brianna stated when Malik told, or asked her (Tony) to leave, Tony started talking "crazy" and threatened to "shoot them." Brianna stated they called TPD two times last night, once was when they were fighting, and the second time Tony had a gun dressed in all black. Brianna stated Tony pointed the handgun at her cousin (Malik) last night and he drove off to get away. I asked Brianna what the gun looked like, and she said it was small and silver.

I asked Brianna about the people seated in the car today, with Malik. Brianna advised she was in the front, her brother (Jaheim) was behind her, and her sister (Ashanti) was seated behind the driver. Brianna stated she saw her (Tony) coming and she (Brianna) told the others "there she goes." Brianna stated Tony walked past and "eased" her way back and opened the driver's side door.

According to Brianna, Tony walked north on Saxon Street, and turned back and walked toward them. Brianna stated Tony stated, "I told you I was coming for you" and just started stabbing Malik. Brianna stated they were all fighting and her cousin (Malik) was "getting all stabbed up." I asked Brianna if she knew how many times Tony stabbed Malik, and Brianna said "not really, she just kept stabbing him." Brianna advised me Malik exited the car, and went across the street where he fell. Brianna said they all jumped in fighting against Tony, and I asked if any of them got cut and she said "No." I asked what Tony was wearing and Brianna stated she was wearing all black with a hoodie and a black ski mask.

After interviewing Brianna, Inv. Copelin arrived. While I spoke to Inv. Copelin, Roosevelt Burgess DOB 01/19/1947, approached me and wanted to provide me with some information. I advised Mr. Burgess once I finished briefing Inv. Copelin I would speak to him.

I made contact with Mr. Burgess in apartment #1, and Mr. Burgess advised me he is roommates with Mr. Nixon and Mr. Nixon's family. Mr. Burgess advised me he was inside his apartment when Malik was stabbed. I asked him if he saw what occurred last night, and Mr. Burgess stated he did. I asked Mr. Burgess if Jennifer and Tony were in a relationship, and Mr. Burgess stated all he knew was they were friends. Mr. Burgess didn't know why there was an argument last night, but Tony came over to apartment #2 "cussing Jen out," Mr. Burgess stated he (burgess) calls Jennifer "Jen."

Mr. Burgess stated Malik was in the apartment ( #2) last night and walked out and asked Tony why she was cussing his mother like that. Mr. Burgess further stated Malik's vehicle was parked differently then it is now, and was over closer to the fence (Saxon Street) last night. Mr. Burgess advised Malik went to his car and got in and Tony told Malik she would fight him. I asked Mr. Burgess if he saw Tony with a gun, and Mr. Burgess advised me he did. Mr. Burgess stated when Tony came over to Jen's home last night, she had the gun and she had a knife. Mr. Burgess stated Tony had the knife in her jacket, and after Tony left last night, Mr Burgess found Tony's black jacket with a gray top in the street down further (south of the apartments) on Saxon Street. Mr. Burgess picked up the jacket and he put it on the chair in front of Tony's apartment.

I asked Mr. Burgess about the gun from last night, and Mr. Burgess stated she (Tony) came out with gun in her hand. Mr. Burgess stated he believed the gun was silver in color, but it was a small handgun. Mr. Burgess stated when Tony went to Jen's house last night, Tony said, "I'll kill all of you M Fers that what I'll do." Mr. Burgess would not say any of the words of profanity he heard and would only use "M Fers" and "Bs" to explain what Tony said. Mr. Burgess stated last night, Tony walked toward Malik with the gun in her hand, while Malik was seated in his vehicle, and Tony started threatening Malik. Mr. Burgess stated Jen came outside and told Malik "nobody is going to mess with you." Mr. Burgess stated a black car pulled up and "Dunk" who is Jennifer's nephew got out. Mr. Burgess stated "Dunk" was trying to talk to Tony last night, and Tony started threatening "Dunk." "Dunk" told Tony if she wants to fight, to come fight him. "Dunk" told Tony "to take it to the street" and Dunk told Tony to put the knife and gun down before they fought. Mr. Burgess stated Tony walked back to her apartment door, and Tony fought in the street and the whole "altercation" occurred in the street last night. Mr. Burgess stated Tony tried to go get the gun, and "Dunk" wouldn't let her.

I then asked Mr. Burgess what he observed this morning, and Mr. Burgess stated "they" ran in and said Malik had been cut. Mr. Burgess stated he saw Malik when Malik ran across the street where he fell down. 365.171(15) Mr. Burgess stated Tony was running down the street saying, "yeah I cut him! and I cut him good!" Mr. Burgess stated Tony ran south on Saxon Street to the second road (Weis Street) and she turned and went toward 2502 Holton Street.

I observed Jahiem Nixon had returned to 2261 Saxon Street, and I was advised, and I confirmed that Inv. Kyle Rowland #743 interviewed Jahiem at 2502 Holton Street.

The above interviews were captured on my TPD issued BWC (body worn camera).

Inv. Copelin requested I show a picture of Natosha "Tony" McDade to the subjects I interviewed and to Jahiem in order to positively ID Tony. I obtained a copy of McDade's DL photograph from Officer Bascom which was sent to my TPD assigned iPhone.



The above picture was shown to Jerry Nixon, Ashanti Nixon, Brianna Nixon, Roosevelt Burgess, and Jahiem Nixon and all five identified McDade as Tony. Mr. Nixon advised me Tony has only lived in apartment #3 for three or four months. In addition to the five witnesses, there were others who responded to the location to be with Malik's family, and many of those subjects saw the picture, and stated that was "Tony."

Inv. Copelin and Forensic Tech Williams processed the scenes, and the vehicle was towed by Lake Jackson. Officer Bascom documented the vehicle's information and the towing of the vehicle in his report and in TRACS.

TPD Inv. Evan Alwin #679 arrived and assisted by escorting the tow truck to the City of Tallahassee's Fleet Management Building, located at 400 Dupree Street, to be processed. Inv. Dan Warren #354 also responded with the vehicle and assisted with the search and securing of evidence with Forensic Tech Williams.

## **CIB SUPPLEMENTAL REPORT- INVESTIGATIVE SUMMARY**

On May 27<sup>th</sup>, 2020, I was contacted by Violent Crime Unit Supervisor Sergeant Butler. The phone call occurred at 11:22 AM. Sergeant Butler requested I respond to the Tallahassee Memorial Hospital reference to a homicide investigation. I was assigned as an Investigator with the Department's Violent Crime Homicide Unit. I would be provided a subsequent brief by Sergeant Butler and Investigator M. Lewis. I learned the male victim died as a result of being stabbed. The female suspect was shot by law enforcement and died as a result. I was assigned to assist with the homicide investigation of the male victim who was stabbed. Investigator M. Lewis was assigned to assist with the Officer Involved Shooting investigation.

When I arrived at the trauma unit at the hospital, the male victim was accompanied by Officers C. Gilbert and A. Nelson. I was briefed by both officers. Officer Nelson was assigned to an off-duty detail at Bond Elementary School. Officer Nelson observed a group who ran from a nearby field. Officer Nelson believed a fight was in progress or just occurred. Officer Nelson responded to the area and discovered the victim on the ground. The victim suffered what appeared to be stab/puncture wounds. According to Officer Nelson there was a female who remained with the victim.

Officer Gilbert was an on-duty patrol officer who was dispatched to the call. Officer Gilbert would be assigned as the primary officer. Officer Gilbert escorted the victim in an ambulance to the hospital. According to medical staff, the victim arrived at the hospital at 11:11 AM. The victim was pronounced deceased at 11:16 AM by Doctor Ashoo. The MR number for the victim's records was 1006679503.

Forensic Specialist K. Stevens responded to the hospital to document the condition of the deceased male victim and collect evidence. Forensic Specialist Stevens swabbed the victim's hands for potential DNA evidence. A buccal/DNA standard was collected from the deceased. Forensic images were taken of the deceased and his injuries. After the images were taken and the hands were processed for potential DNA evidence, I conducted an external visual examination of the deceased.

The deceased was a black male between approximately 18 and 25 years old. He had a distinct tattoo on his left forearm "Jennaviyah." Evidence of medial intervention was present. This included oral intubation and the presence of medical leads. His clothing appeared to be cut from his body for medical intervention purposes. I observed a shallow puncture wound to the top of his left shoulder. A wider and deeper puncture wound was observed behind the deceased's right ear. I was told there was a puncture/stab wound to the deceased's chest. This injury was not visible as it was covered by a medical apparatus. I observed two lacerations to the deceased's left arm. Two like lateral lacerations were on either side of the deceased's abdomen. I was told these incisions were made by medial staff during lifesaving efforts.

Suspected blood was present over the deceased's person. This included his hands and fingers. No overt

defensive injuries were discovered on the deceased's hands. Minimal lacerations or abrasions could be masked due to the suspected dried blood and would be more visible during autopsy.

I contacted the Medical Examiner's Office and spoke with Deputy Medical Examiner Doctor Flannigan. I provided her with a summary of this investigation. Doctor Flannigan scheduled the autopsy for the deceased on May 28<sup>th</sup>, 2020 at 9:30 AM. Investigator S. Bennett was tasked to attend the autopsy. I coordinated with Violent Crime Unit Investigator K. Isaacs in efforts to identify the victim. The victim's fingerprints were queried in the Rapid ID system without success. Ultimately, the victim was positively identified as Malik Jackson. In addition to a visual comparison to recent images, the unique tattoo on the victim's left forearm was used to confirm identity. I would be advised the victim and suspect were involved in an altercation where law enforcement was summoned the previous night.

Victim Jackson was sealed in an evidence bag by Forensic Specialist Stevens. Officer Gilbert would escort victim Jackson to the Medical Examiner's Office. Victim Advocate E. Hall responded to the hospital and made the next of kin notification with Investigator M. Ray. The next of kin was identified as the deceased's mother, Jennifer Jackson. After I completed investigatie efforts at the hospital, I responded to the scene located at 2200 block of Saxon Street. I coordinated with Sergeant Butler and Investigator D. Copelin. Investigator D. Copelin was assigned as the lead investigator for this case. I learned victim Jackson was stabbed inside of his vehicle. The vehicle was on scene when I arrived. I did not have any contact with the vehicle while it was on scene.

The vehicle was a silver Hyundai Santa Fe with Florida license Plate: IP97GZ. I was informed the vehicle was registered to solely to victim Jackson. I learned no other person had a fourth amendment privilege for the vehicle; it was determined the vehicle would be searched and processed without a search warrant.

The vehicle was transferred by the department's contract wrecker service to a secured storage bay at the City of Tallahassee's Fleet Department. This bay is used by the police department to process vehicles. Before the vehicle was transported, the doors and hatch were sealed with department evidence tape.

I arrived at the evidence bay at 2:34 PM. Forensic Specialist E. Williams opened the secured bay. Forensic images were taken of the vehicle. The evidence tape on all entry points were intact. Images of the intact evidence tape at the evidence bay were taken. Thereafter, the evidence seals were broken, and overall images were taken of the inside of the vehicle. Forensic Technician Williams processed the vehicle for potential DNA evidence. This included samples from all door handles, steering controls, and individual seat backs. After the vehicle was processed for potential DNA it was searched for potential evidence. I coordinated with Investigator D. Copelin as he was the lead for the case. The search was limited to weapons, DNA, and latent evidence. Investigator Copelin excluded electronic devices from the scope of the search to be conducted.

I started the search at the front driver's side compartment. I discovered suspected blood on, beneath, and

below the interior door latch. Suspected blood droplets were discovered on the front driver's seat cushion and seat back. Victim Jackson's Florida Drivers License was discovered wedged against the plastic partition for the driver's console/gauges. A serrated steak knife with a black handle was discovered in the front driver's side door compartment. Next I searched the rear driver's side compartment. An open soda can was discovered in the rear door pocket cup holder. The lip/rim was swabbed for potential DNA evidence. Thereafter, I searched the trunk/rear hatch compartment. I discovered a second Florida Drivers License for victim Jackson inside of a backpack located inside the rear compartment. The rear passenger side compartment was searched next. The final compartment searched was the front passenger compartment. Victim Jackson's Social Security Card was discovered inside the center console. Suspected blood was discovered on the interior of the front passenger side compartment window. Forensic Technician Williams took samples from all suspected blood discovered inside the vehicle. During the search it was apparent the front driver floor mounted gear shift was damaged. A part of the gear shift was discovered on the floor of the front passenger compartment. After the search was completed, Forensic Technician Williams processed the vehicle for potential latent evidence.

After the vehicle was processed, it was towed by the department's contract wrecker Lake Jackson to the Lake Jackson tow yard. I consulted with Investigator Copelin who decided no hold would be placed on the vehicle.

After the vehicle was released, I went to the police department and participated in a briefing for this investigation. I updated fellow investigators with the information gained from the search of the victim's vehicle. As of this report, I did not participate in any additional investigative actions for this case. Any additional significant actions will be documented in a supplemental report.

This investigation retains its previous disposition.

#### Supplemental Report- Homicide

On 05/27/2020 I responded to 2502 Holton Street in reference to a homicide and officer involved shooting. Upon arrival I met with TPD VCU Investigator Roberts and Lt. Creamer. Inv. Roberts asked I begin speaking with witnesses to either the shooting or the stabbing at 2261 Saxon Street.

TPD Inv. Ouzts and I began walking around the B building to interview witnesses on the northside of the complex. I was flagged down by a black female who advised a woman in apartment #B110 was having seizures and trouble breathing. I arrived at the backdoor of apartment #B110 and heard yelling from inside. After knocking on the door, I was let inside and observed a black female on the couch hyperventilating and crying. Someone in the room identified this female as the grandmother to the male victim in the stabbing, Malik Jackson. Several family members had told the grandmother of Malik he was stabbed to death by the suspect Natosha McDade.

EMS was summoned by another Officer on scene and they took over medical treatment. I began speaking to several family members and I was able to obtain a verbal statement from Abigail Jackson. Jackson advised she was the aunt to Malik Jackson and the sister of Jennifer Jackson. I was later able to positively identify Jackson via her Florida Driver's License. Abigail advised Notasha was "obsessed" with Jennifer Jackson, Abigail's sister.

Around 07:30pm Abigail received a call from her son on 05/26/2020. He said family members had to fight Notasha after she pulled out a gun and told everyone she would kill them. Abigail called TPD and spoke to Officers. Abigail further stated Notasha was mentally ill, smoked molly and was very dangerous.

On the morning 05/27/2020 her son came to her and said Malik had been stabbed by Notasha, and Jaheim had tried to fight Notasha off. Abigail heard Notasha was coming to apartment #B110 to kill Abigail's mom. Abigail also knew Notasha had been on Facebook Live on the night of 05/26/2020, threatening to kill everyone. Abigail was able to direct me to Jaheim Mixon, who was with Malik when he was stabbed.

Jaheim advised the following:

On the morning of 05/26/2020 Jaheim was in a car with Malik, Landre "Dre" Lundy, and his sisters, Briana and Ashanti. The vehicle was parked in the driveway of 2261 Saxon Street. Jaheim advised he saw Notasha, dressed in all black and holding a large knife, walking towards their vehicle. Jaheim was not sure which direction she came from, but she walked up to them on foot. Notasha came and opened the driver's side door, where Malik was sitting. Jaheim was not sure if the Malik was wearing a seat belt or not.

Notasha stabbed Malik several times in the back of the head, the side under his left arm, and his chest. Jaheim pointed to the areas of his body wear Malik was stabbed. Jaheim described the knife a "large Kitchen knife". Jaheim was not sure how many times Notasha stabbed Malik, but advised it was several times.

Jaheim got out of the back seat and ran around to the driver's side. Malik was trying to crawl out of the passenger's side with Dre's help. Jaheim started to fight with Notasha over the knife. Notasha was on top of Malik's back, still trying to grab him and stab him. Jaheim was able to get the knife from Notasha and he stabbed her several times.

Malik was able to get out of the passenger side of the vehicle. Jaheim was able to pull Notasha off and he slammed her on the ground. Malik ran away and Notasha pulled a gun out. Jaheim and Notasha wrestled for control of the gun. Jaheim yelled for Malik to run away at this point. Jaheim stabbed Notasha again and ran away. Jaheim described this gun as a small "25 caliber" handgun, with some silver on it. Jaheim had seen Notasha with the gun the night before (05/26/2020).

Jaheim and Malik ran across the street and into the field. Malik collapsed at this point and he remained in the field. Notasha followed them and was pointing the gun at both of them. Jaheim was not sure why Notasha did not fire the gun. Notasha left on foot and police came. When Notasha left, she still had the gun in her hand and the knife was still somewhere by their car.

Jaheim advised he had some blood on his hands, but he went home and washed after police came. Jaheim also changed his shorts and came to the apartment at Holton Street. This is were Jaheim learned Notasha was shot by a TPD Officer.

Jaheim described the incident night before (05/26), when Notasha came to their house on Saxon Street. Notasha had a knife and the same gun at that time. Notasha was looking for Jennifer and they told Notasha to leave. When she did not leave, the group "jumped" Notasha and started to hit her. Jaheim advised the group had some mercy and let Notasha go. TPD Officers came but Notasha was gone. Notasha later same back to the Saxon Street house. TPD Officers came again, but Notasha left. Jaheim and Dre explained Notasha had been on Facebook Live, threatening to kill them all.

I spoke to Dre on scene as well, separate from Jaheim. Dre advised nearly the same as Jaheim. Dre was sitting in the vehicle at the Saxon Street house. The house belonged to Dre's aunt, Jennifer Jackson. Notasha "came from out otta nowhere" and started stabbing Malik 8 to 12 times. Dre described the knife as just a blade, no handle. Dre advised the knife was left by the vehicle. Dre and Jaheim were able to get Malik out of the passenger side of the car. Jaheim stabbed Notasha at least once to stop her from attacking them.

After getting Malik out of the vehicle, they ran away from her. At some point Dre did punch Notasha to also stop the attack. Dre saw Notasha with a gun in her hand, pointing it at them. Dre was not sure where Notasha pulled the gun from, and he did not see her with a gun the night the night before. Dre, Malik and Jaheim ran across the street Notasha left the area on foot.

After speaking to all parties, I informed Inv. Dan Copelin of the results of my investigation. All my interviews and interactions were captured on my body worn camera.

During the morning of May 27, 2020, while I was in my office at the Leon County Sheriff's Office (LCSO), I heard commotion, via my department issued police radio, of what sounded like an officer-involved shooting (TPD Case 2020-83393) in the area of 2502 Holton Street, Tallahassee, Leon County, Florida. Moments went by and I was requested to respond to the Tallahassee Memorial Hospital (TMH) to assist with possible crowd control issues if family/friends of the involved patients arrived there wanting to see the involved patient(s).

I arrived at TMH's emergency room (ER) but did not encounter any family members or friends of the patients. I was later told family/friends had arrived already and been turned away prior to my arrival. I made contact with Tallahassee Police Department (TPD) Violent Crimes Unit (VCU) Investigator Mark Lewis, who was already with one of the patients in the ER prior to my arrival, but he informed me he did not need any assistance from me. I then made contact with TPD VCU Investigator Dan Warren, who was already with one of the other patients in the ER prior to my arrival. Investigator Warren asked me to respond to 2261 Saxon Street (location of the stabbing, TPD Case 2020-83392) to canvass for evidence and witnesses.

I responded to LCSO to retrieve necessary paperwork (blank statement forms, property receipts, etc.). As I was about to walk through the main door, I was approached by a dark brown skinned black male subject (wore a black or gray shirt) who informed me an officer told him to respond to TPD to provide a statement regarding him eye witnessing of the officer-involved shooting. I told him to wait outside (LCSO COVID-19 social distancing protocols were in place) while I go upstairs gather paperwork for him to provide a sworn written statement. However, when I came back outside, he was gone. I later provided TPD VCU Sergeant Bill Butler with the information contained within this paragraph.

I responded to 2261 Saxon Street and made contact with TPD Investigator Dan Copelin, who requested for me to assist TPD Forensics and Larry Chester (Lake Jackson Wrecker Employee) load an involved vehicle (silver Hyundai Santa Fe SUV bearing Florida License Plate IP97GZ) onto a Lake Jackson flatbed tow truck. After this was completed and the vehicle was towed from the scene, Investigator Copelin requested for me to interview a witness (later identified, and verified through Florida's Driver and Vehicle Information Database (DAVID), as Abigail Jackson). Jackson provided me with the following:

Last night (May 26, 2020), at approximately 7:45pm, her son (Vonderrekus Paden) called and informed her that Natosha McDade (aka "Tony") came to Jennifer Jackson's (Abigail's sister) residence (apartment number two of 2261 Saxon Street, Tallahassee, Florida), forced her way inside (via the front door after it was opened for her) and began a verbal altercation with Jennifer while holding a firearm and a knife. Jennifer and McDade had been in an intimate relationship in the past. McDade wanted the relationship to continue but Jennifer did not. According to Abigail, Jennifer and McDade had known each other for at

least six months and they were next door neighbors. Apparently "Glen" (another one of Abigail's sons) told McDade to drop her weapons and he would fight her himself. McDade complied and was ultimately "jumped" by at least five unidentified persons. Word got back to Abigail that McDade had posted a Facebook Live video holding a firearm and threatening to kill "everyone" after the physical altercation. Abigail never actually saw this video, but she claimed she called TPD to report the altercation. According to the CAD, there was a call for service (TPD Case 2020-83015) at the incident location on May 26, 2020, at approximately 8:15pm. TPD Patrol Officer Joseph Smith wrote a report and his narrative was as follows:

"On 05/26/2020, I was assigned to the Uniform Patrol Division of the Tallahassee Police Department in Tallahassee, FL, Leon County. I was assigned to the Southern District of Tallahassee, operating a marked patrol vehicle and wearing a standard patrol uniform. I was dispatched to 2261-2 Saxon Street (within the city limits of Tallahassee), in reference to a disturbance involving a weapon.

I arrived on scene and made contact with Jennifer Jackson while Ofc. Roberts #333 spoke with Voderrekus Paden. Jackson resides in unit #2 and the suspect, Natosha McDade, resides in unit #1. On today's date, Jackson was inside of her residence and the front door was unlocked. McDade opened the unlocked door and came into Jackson's living room. McDade began arguing with Jackson over their prior relationship. The verbal argument ended, and McDade walked outside as Paden arrived in his vehicle. Paden is Jackson's nephew. Paden overheard McDade and Jackson arguing, and Paden did not like how McDade was talking to his aunt (Jackson).

Paden and McDade began arguing in the front yard of the tri-plex. McDade brandished a black .22 caliber pistol from her waistband, held it by her side briefly and then put the pistol inside her residence (#3). McDade came back outside and continued to argue with Paden. McDade pulled out a pocketknife from her pants pocket and then put it back inside of the pocket during the argument. Paden stated he was not in fear of his life when the weapons were brandished. McDade did not point the weapons at anyone, and Paden stated he was never threatened with the weapons. McDade and Paden continued to argue with each other and then the two began fighting. Paden stated McDade punched him first and then he punched her back. The two fought with each other for a short period of time and then McDade walked away south on Pasco Street. Paden stated he was not injured, and he stated he did not think McDade was injured. There were no visible injuries on Paden, and he refused to provide a sworn written statement. Jackson stated she did not witness the physical altercation because she was inside when it occurred. Jackson refused to provide a sworn written statement but stated she wanted to press charges against McDade for entering her residence without permission.

Ofc. Roberts and I attempted to make contact with McDade but she was not home (no answer at the

door). McDade was described as a black female that looked "manly," appr. 5'8"-5'10", thin build, light skin complexion with short hair.

My interaction on scene was captured on my department issued body worn camera (BWC). This concludes my involvement in this incident."

There was another call for service (TPD Case 2020-83065) two-hours later (at approximately 10:14pm) and the narrative of TPD Officer Summer Robinson's report was as follows:

"On May 26th, 2020, at approximately 10:14 PM, I responded to 2261 Saxon Street unit 1 in reference to a weapons call. The notes advised the suspect from an earlier incident was on scene again with a gun. See TPD 2020-00083015 for that incident.

Upon arrival, I did not locate anyone in the area. The suspect was described as a light skin black female with a bald head. She had tattoos on her arms and neck. She goes by "Tony" and lives in unit 3. She was approximately 40 years old. I recognize the suspect description from a recent incident as a Natosha McDade who resides in unit 3.

The complainant, Mia Nixon, advised she heard yelling in front of her unit. Her brother was outside and about to leave. She advised when she looked outside she saw her brother driving off. She also saw "Tony" looking at the door yelling "I'm gonna get you" with a gun in her hand. Mia advised her sister, Ashante Mixon, also saw her with the gun. Mia advised they locked the door and ran to hide. When she looked out the window again, they did not see Tony and did not know where she went.

I asked Mia if she was threatened by Tony or if Tony talked to her and she advsied they did not speak to Tony. They just saw her yelling with the gun. Tony was unable to be located in the area.

My encounter with the above parties was captured on my body worn camera.

This concludes my involvement."

This morning (May 27, 2020), Paden called Abigail and informed her McDade had just stabbed Malik (Abigail's nephew) as he sat inside of his vehicle (the silver Hyundai Santa Fe mentioned earlier that was towed from the scene). Allegedly, Paden did not visually witness this incident but rather received this information from an unidentified third party. Abigail armed herself with a shovel, left her residence (685 Henry Jones Road, Tallahassee, Leon County, Florida) driving her black 2020 Chevrolet Equinox SUV (bearing Florida License Plate BZIV55) and arrived on scene of the stabbing (2261 Saxon Street) but

neither McDade nor Malik were on scene any longer.

Abigail provided me with a sworn written statement, which I later uploaded to the case file in LERMS along with the Administration of Oath/Perjury Warning for Witness she signed. TPD Forensics seized the shovel, which Abigail had brought to the scene, to be impounded as evidence at TPD.

As of now, this concludes my involvement in this incident.

I went to look for the suspect as we were told she was standing on the street south of our location. I was informed it was not the suspect and returned to the original location. EMS had arrived and were about to transport the victim. I began putting up crime scene tape blocking off the lot and was told the victim was stabbed while in a vehicle across the street. I then placed crime scene tape around a small silver SUV. As I was doing so, officers called out with shots fired at Holton Street. I was relieved by Officer Bascom 518 and responded to Holton Street.

The first subject I attempted to ID came back "no hit".

The second one I did came back with a hit and positively identified Natosha McDade. The information was then used to obtain a photo for Inv. Lewis using our electronic database. We were able to positively identify Natosha McDade.

While on scene, Inv, Lewis came up with a potential name "Malik Jackson" for the other subject that was not identified originally. Through electronic database we were able to positively identify Malik Jackson as the other deceased person.

After both were positively identified, they were transported to the morgue. I assisted with the escort of Natosha McDade to the morgue and made sure she was logged in when she arrived. This concludes my supplement for this report.

On May 27, 2020 while working an off-duty detail at Bond Elementary, 2204 Saxon St. I noticed multiple juveniles running across the street to an open field. The open field is in the 2200 block of Saxon St. and Tucker St. I initially thought the juveniles were about to engage in a fight. I walked over to the open field to investigate the matter. Upon my arrival, I observed a black male wearing a black t-shirt, green boxers, long black pants and red sneakers laying on his left side in the middle of the field. Another juvenile wearing a black t-shirt and blue shorts was squatting next to the victim. I was advised by the unknown juveniles near the scene that a bald black female wearing all black stabbed the victim. They were unsure of the direction of travel of the female suspect, but advise she was on foot. Contact was made with the victim and I observed multiple stab wounds. The victim had a laceration to his upper chest, behind his right ear, and two lacerations on his right bicep. The victim was conscious but not using verbal's while I was dressing the wounds. Officer Gilbert #622 arrived on scene and the victim was still conscious. A few minutes later the victim was unresponsive, and I started CPR compressions. After a few minutes Ofc. Gilbert took over the compressions, but we were unable to gain a pulse. EMS arrived on scene and took over CPR inside of the ambulance. Ofc. Gilbert stayed with the victim and I followed behind EMS. Upon arrival at the Tallahassee Memorial Hospital (TMH), Dr. Ashoo called the time of death at 11:17 a.m.

This concludes my involvement in this case.

#### Homicide-Supplemental Report:

While on marked patrol, I responded to the Bond Neighborhood regarding requests for additional assistance due to a stabbing scene located on Saxon St. I made contact with Sgt. Miller #285 who was standing in the roadway near the intersection of Saxon St/Tucker St. Sgt. Miller informed me that he was currently watching two separate crime scenes related to the stabbing (one located at 2261 Saxon St, and one in a vacant lot at 2260 Saxon St). Both crime scenes had been marked off with crime scene tape when I arrived.

I checked around a silver Hyundai Santa Fe parked in front of 2261 Saxon St that had been wrapped with crime scene tape and observed the blade end of what appeared to be a kitchen steak knife. The knife blade was laying on the driveway next to the front passenger side of the silver vehicle, and appeared to have blood on it. I extended the crime scene perimeter of the vehicle to include the location of the knife. Laying on the sidewalk on the east side of Saxon St, just south of the intersection was a small shovel that appeared to be out of place, but had not been indicated as anything involved with the incident.

CIB Inv. Pinkard and TPD Forensics arrived on scene to begin working on the incident. I assisted with monitoring the crime scene at 2261 Saxon St involving the victim's vehicle. Ofc. Endara #766 was watching the crime scene at 2260 Saxon St. I checked 2260 Saxon St and observed where the victim (Malik Jackson) had been laying. At 2260 Saxon St, several medical supply wrappers were observed along with a single red sneaker. Also observed were numerous blood droplets along the street and sidewalk leading from the southeast corner of the intersection, diagonally towards the vacant lot at 2260 Saxon St.

While still on scene, Inv. Copelin arrived to assume lead on the investigation. He directed me to have the victim's vehicle towed via Lake Jackson to City of Tallahassee Fleet for Forensics processing. A towing form was completed via TRACS and submitted, with a copy given to the driver of Lake Jackson Towing. An email was sent to TPD Vehicle Impounds regarding the tow.

A black Chevy Equinox arrived on scene which matched one described by Ofc. Endara that he passed on his way to the scene. I informed investigators on scene of the vehicle, and an interview was conducted with the driver, who turned out to be the aunt of the victim. I assisted Inv. Johnson with video recording of the interview, which revealed that the small shovel was brought to the scene by the driver of the Equinox.

This concluded my involvement in the incident. I did not conduct any independent interviews nor collect

On 5/27/20, I responded to 2261 Saxon St in reference to Ofc. Nelson #746 notifying dispatch a subject had been stabbed. The subject was later identified as Malik Jackson. The suspect was described as a bald, black female wearing all black. She was later identified as Natosha McDade.

Upon arrival I observed two vehicles parked, one facing north and one facing south, in the roadway on Saxon St, along with a couple of people standing on the westside of the roadway. I immediately parked my marked patrol vehicle behind one of the cars and exited to make contact with the unknown subjects to see if they knew any information regarding the stabbing. At this point I observed Ofc. Nelson in the southwest corner of the open lot kneeling beside Jackson, who was wearing black pants, one red shoe, and no shirt. I ran over to assist Ofc. Nelson and observed Jackson laying on his back with his head facing south and feet facing north. His arms were out to his side, legs were straight out, eyes were open, and he was still breathing, but going in and out of consciousness. I observed a puncture wound behind his right ear, puncture wound to the center of his chest and two lacerations to the back of his right bicep.

Ofc. Nelson and I kept yelling at Jackson to stay awake and shaking him to keep him alert. Jackson then stopped breathing and had no pulse. Ofc. Nelson began chest compressions while I opened his airway. I then took over and began doing chest compressions while she used the mask to do breaths. Dispatch was notified that CPR was in progress and EMS was already enroute. CPR remained in progress until EMS arrived on scene, Jackson remained pulseless the entire time. EMS crew and I carried Jackson by his arms and legs to the stretcher and loaded the stretcher in the back of the ambulance (RUN # 20-0017904, crew FOSTER, MCCULLOUGH). I rode with EMS to TMH, while Ofc. Nelson followed in her marked patrol vehicle. Aid was rendered the entire transport with no pulse still being found. Once at TMH, Ofc. Nelson and I followed Jackson into the Trauma bay where medical staff tended to Jackson. Dr. Ashoo pronounced Jackson deceased at 11:16 am.

SVU Investigator Warren arrived at TMH and contacted the ME, Dr. Flanagan, who advised this would be an ME case and the autopsy would be conducted tomorrow 5/27/20 at 9:30 am. Forensics tech Stephens #821 arrived at TMH and did swabs on Jacksons hands. At 1:24 pm, Tim Blair with Culleys Funeral Home, arrived at TMH to transport Jackson to the county morgue. Jackson's body was placed into a body bag, which was then secured with evidence tape and a tagged by Stephens #821. I followed behind the transport vehicle to the morgue. At 1:59 pm, Jackson's body was turned over to ME staff Tiffany Post.

This incident was captured on my BWC and downloaded for evidence.

I was advised that the decedent had been stabbed while inside of a vehicle parked in front of the apartments at 2261 Saxon Street. The vehicle was a silver Hyundai Santa Fe (FL. license plate IP9 7GZ). I photographed the vehicle.

I was told that the decedent had ran from the drivers seat area of the vehicle after being stabbed, and collapsed in a vacant lot in the 2200 block of Saxon Street approximately 178 feet Southwest of the vehicle. The decedent had already been transported to the T.M.H. Emergency Room prior to my arrival. I took photographs of the scene including the vehicle, drops of suspected blood from the vehicle to the vacant lot, and the vacant lot where the decedent collapsed. While assigned to the Criminal Investigations Bureau, I conducted a follow up investigation regarding this homicide. On May 27, 2020, I was contacted during regular business hours by Sergeant W. Butler regarding this investigation. I responded from my residence to the scene and incident location, at 2261 Saxon Street, Tallahassee, Florida. This address is a townhouse triplex located on the southeast corner of the intersection at Saxon Street and Tucker Street. The triplex, despite having a Saxon Street address, faces north on Tucker Street. The address for each townhome is numbered one through three, counting up from west to east. The triplex shares a wide common driveway/parking area for residents and guests.

Upon my arrival, the crime scene had been cordoned off with crime scene tape and a patrol officer was maintaining the perimeter. This included a 2004 Hyundai Santa Fe SUV (Florida license plate IP97GZ, VIN KM8SC13E94U589220) which was parked in the driveway, facing south, in front of apartments #1 and #2. The vehicle is registered to Malik Jackson. The vehicle had been surrounded with crime scene tape and a small area around the vehicle was controlled by patrol officers. There was suspected blood evidence on the concrete around the vehicle. A single broken knife blade was discovered on the concrete to the west of the vehicle. The blade was broken at the hilt from any handle and appeared to have suspected blood evidence on the surface. There was no handle located in the vicinity. There was suspected blood evidence located in and on the vehicle identifying it as part of the crime scene. This portion of the crime scene was identified as crime scene 1, or the primary scene.

In addition to the vehicle, the empty lot located at 2260 Saxon Street (west of the triplex and across Saxon Street) was cordoned off with crime scene tape and a patrol officer was maintaining the perimeter. Between the vehicle and the vacant lot, evidence markers were placed along suspected blood evidence on the sidewalk behind the vehicle then crossing Saxon Street in a southwest direction towards 2260 Saxon Street.

In the vacant lot at 2260 Saxon Street, the leaves and ground cover were disturbed and surrounded by evidence of medical paraphernalia due to the resultant efforts providing medical intervention to the victim by first responders. Additionally, a red Asics brand athletic shoe was in this same immediate area. The shoe was for the right foot and the shoelaces were untied. The distance measured from the vehicle driver's door (crime scene 1) to the shoe was approximately 178 feet. This portion of the crime scene in the vacant lot was identified as crime scene 2, or the secondary scene.

After an initial assessment of the crime scenes, I obtained a description of the incident from the officers/investigators who preceded my arrival. In summary, there were multiple witnesses regarding the suspect attacking and stabbing the victim. The victim, who had been seated in the driver's seat of the vehicle, exited while injured and walked to the vacant lot where he laid or fell to the ground. The suspect made statements prior to leaving on foot. Moments later patrol officers located the suspect at 2502 Holton Street, Tallahassee, Florida (approximately five blocks away) and the resultant contact escalated immediately to a deadly force response (TPD case 20-83393). The suspect was pronounced deceased at TMHER. The victim had been transported from the scene to Tallahassee Memorial Hospital Emergency Room (TMHER) via Leon

County Emergency Medical Services (RUN 20-0017904, EMS crew Foster and McCullough) where he was pronounced deceased at 1116 hours. Both investigations and crime scenes were active simultaneously.

The victim was positively identified as Malik Jackson, black male, date of birth 10/29/1998. The deceased suspect was positively identified as Natosha "Tony" McDade, date of birth 6/18/1981. Multiple witnesses involved in this investigation refer to McDade as "Tony."

Investigator D. Warren assisted this investigation. He was initially tasked with responding to TMHER regarding the victim and potential evidence. He later assisted with documenting the crime scene vehicle. Investigator Warren learned at the hospital the victim succumbed to his injuries as a result of being stabbed. Officers C. Gilbert and A. Nelson accompanied the victim to the hospital and spoke to Investigator Warren. Officer Nelson advised: She was working in an off-duty detail capacity at Bond Elementary School located at 2204 Saxon Street, Tallahassee, Florida. This is across Tucker Street from the incident location. She observed several subjects running across the street and believed a physical altercation was occurring. She left the elementary school to investigate and located a black male (Malik Jackson) lying on the ground at 2260 Saxon Street. Jackson was injured and was being attended to by an unidentified juvenile. Several of the unidentified juveniles made statement Malik Jackson had been stabbed by "a bald, black female wearing all black." The suspect had fled on foot in an unknown direction. Officer Nelson observed Jackson was suffering from multiple stab wounds. According to her supplemental report, Jackson was conscious but, made no statement while she attempted to provide medical treatment. While providing medical assistance, Jackson lost consciousness and became unresponsive. Officer Nelson started CPR compressions when it was determined Jackson had no heartbeat and wasn't breathing. Officer Gilbert assisted with CPR until Leon County EMS arrived. CPR continued during the transport to TMHER. Officer Nelson completed a supplemental report.

Officer Gilbert advised when she first observed Jackson he was "in and out of consciousness" and suffering from multiple stab wounds. She assisted with CPR and began performing chest compressions as Officer Nelson provided rescue breathing with a mask. Officer Gilbert rode in the ambulance with Jackson to TMHER. Officer Nelson followed in a patrol vehicle. Officer Gilbert completed a supplemental report.

Forensics Technician K. Stevens responded to assist Investigator Warren at TMHER with photographing, documenting, preserving and collecting evidence. Following these efforts, Investigator Warren completed an external visual examination of the deceased. Evidence of medical intervention was present. Deputy Medical Examiner Doctor Lisa Flannagan was contacted, and an autopsy was scheduled for the following day. Investigator S. Bennett was tasked with attending the autopsy.

Investigator Warren made efforts to positively identify the deceased. Efforts to utilize the Rapid ID fingerprint identification system were unsuccessful. Ultimately, the deceased was positively identified as Malik Jackson by visual comparison of recent images and the unique tattoo on the victim's left forearm.

The body bag was sealed as evidence by Forensics Technician Stevens then escorted by Officer Gilbert to the

Medical Examiner's Office from TMHER.

Victim Advocate E. Hall assisted at TMHER with making next of kin notification to Jennifer Jackson, mother of the deceased.

Forensics Technician E. Williams responded 2261 Saxon Street to photograph, document, preserve and collect evidence at the crime scene.

Due to anticipated incoming inclement weather, the vehicle was secured with evidence tape and towed from the scene by contract towing company Lake Jackson Towing. The vehicle was towed to the secure storage facility at City of Tallahassee Fleet division on Dupree Street. This location is used by the police department to process vehicles. The vehicle was accompanied by Investigator E. Alwine who confirmed the vehicle was unmolested and the evidence tape remained intact and secure before, during and after the transport. The vehicle was secured in the facility until it was processed later by Forensics Technician Williams, accompanied by Investigator Warren. See their supplemental reports for details, in addition to those listed below.

At the primary crime scene, prior to the vehicle being removed and towed, the broken knife blade was collected. Additionally, several locations of suspected blood evidence were swabbed or documented on/around the vehicle. This included on the concrete driveway beside the vehicle, the sidewalk area north of the vehicle and along the sidewalk as it traveled west then south at the intersection.

Photographs were taken of the directional evidence markers crossing Saxon Street to the secondary scene (2260 Saxon Street) and disturbed ground cover area. These indicated some suspected blood evidence and some swabs were collected. Photographs were taken of the secondary scene. This included the red Asics athletic shoe, evidence of the medical intervention (bloody gauze, packaging, etc.) and a directional evidence marker towards the disturbed ground cover.

Investigator K. Pinkard assisted at Saxon Street interviewing witnesses. The following descriptions and accounts of the interviews were all completed at the scene.

Jerry Nixon was interviewed. Jerry Nixon initially stated, "my son, he saw everything." It was discovered Jerry Nixon was referring to Jaheim Nixon. Jerry Nixon was a witness to statements made by others on scene and the descriptions of the incident they provided. According to Investigator Pinkard's supplemental report, Jerry Nixon explained he became aware something happened when his daughter ran into the house exclaiming Malik Jackson had been stabbed. He observed Malik Jackson run across the street and collapse. While making this statement, Jerry Nixon pointed towards 2260 Saxon Street (the secondary scene). He also observed the subject, who he believed was McDade, running south on Saxon Street from the scene wearing a hoodie and mask. Investigator Pinkard asked if Jerry Nixon knew who the suspect was, and he replied "yes" while pointing to 2261 Saxon Street #3. Jerry Nixon named the suspect as "Tony."

Jerry Nixon also described an altercation which occurred the previous date (May 26, 2020) at 2261 Saxon

Street #2. During the altercation, Malik Jackson told "Tony" not to come into his mother's residence "like she owned the house." Jerry Nixon also described ongoing problems between the residents of 2261 Saxon Street #3 and #2. Jerry Nixon stated, "Tony like Malik's mother (Jennifer Jackson)... Jennifer told Tony 'I don't go that way' meaning she (Jennifer) wasn't homosexual." Jerry Nixon described "Tony" as appearing masculine and having a bald head. He added, Jaheim Nixon, took the knife away from the suspect during the stabbing. Jaheim Nixon would later be located 2502 Holton Street and interviewed by Investigator K. Rowland. See below for details.

Investigator Pinkard interviewed Ashanti Nixon. Ashanti Nixon provided a description of the incident. This description included where the victim and witnesses were seated in the vehicle located in the primary crime scene. She was seated in the rear seat, on the driver's side. Brianna Nixon was seated in the front passenger seat. Malik Jackson was seated in the driver's seat. Jaheim Nixon was seated in the rear seat, on the passenger's side.

As background to the stabbing, Ashanti Nixon related information regarding the altercation which had occurred the previous night (May 26, 2020) "between my Aunt Jen (Jennifer Jackson) and the lady that stabbed him (Malik Jackson)." She referred to the suspect as "Tony" and a resident of 2261 Saxon Street #3. Ashanti Nixon pointed to this apartment when describing where "Tony" resides. Jennifer Jackson was upset "Tony" had entered her house. Jennifer Jackson told "Tony" to leave. When "Tony" refused Malik Jackson intervened and told "Tony" to leave. According to Ashanti Nixon, "Tony" tried to fight Malik Jackson after being told to leave. Ashanti Nixon saw "Tony" with a handgun and described it as being small and silver in color. She referenced TPD being called to the location for the incident and placing a second call for service when "Tony" returned again, still armed with a handgun.

Regarding the stabbing, Ashanti Nixon explained the group had been in the vehicle together for approximately thirty to sixty minutes. She described the event as follows, while sitting in the vehicle "Tony" opened the driver's door and started stabbing Jackson with a knife. Ashanti Nixon was confused how "Tony" opened the door because she believed the doors were locked. She explained "everybody" tried to stop "Tony" and fight ensued in an effort to help Malik Jackson. Ashanti Nixon stated Malik Jackson had no way to protect himself while "Tony" was stabbing him. Following the stabbing, or during a pause in the attack created by others intervening, Malik Jackson exited and ran to the secondary scene. According to Ashanti Nixon, after being injured Malik Jackson made statements about being "tired" and was focused on trying to catch his breath. Ashanti Nixon heard "Tony" state, "I'm going to finish all y'all, I'm going to kill all y'all!" while leaving and running in the direction of 2502 Holton Street.

Investigator Pinkard interviewed Brianna Nixon. Brianna Nixon confirmed she was present for the altercation which occurred the previous night (May 26, 2020). Brianna Nixon stated "Tony" threatened to kill Jennifer Jackson as she "tried to leave her." She explained this was an ongoing issue because, "Tony" is "crazy" and in love with Jennifer Jackson. When asked to describe their relationship, Brianna Nixon stated they were more

like "friends" than in a romantic relationship however, "Tony" thought there was more. This belief was despite of statements from Jennifer Jackson to "Tony" explaining they were just friends. During the altercation, Brianna Nixon witnessed "Tony" being told to leave Jennifer's house. This upset "Tony" who "started talking crazy" and threatened to "shoot them." Brianna stated TPD was called to the location on two separate occasions as result of "Tony." The first time when a fight occurred and the second time when "Tony" was armed with a handgun and pointing it at people. Brianna Nixon claimed "Tony" pointed the small silver handgun at Malik Jackson. Malik Jackson drove away while this was happening.

See below for some of the details about the two call for service incidents. The details are contained in the witness statements which follow below. It should be noted, the events are best documented in the respective original reports and supplemental reports.

Brianna Nixon described where everyone was seated in the vehicle. She was seated in the front passenger seat, Jaheim Nixon was in the rear passenger side seat and Ashanti Nixon was seated in the rear driver's side seat. While they were sitting in the vehicle, Brianna Nixon observed "Tony" approach the vehicle and stated, "There she goes" referring to "Tony." "Tony" walked past the vehicle and then returned to open the driver's door while stating, "I told you I was coming for you" and started stabbing Jackson. The group began fighting "Tony" in an effort to stop the attack. While they were fighting Brianna Nixon described Jackson was "getting all stabbed up." When questioned about how many times "Tony" stabbed Jackson, Brianna Nixon replied, "not really, she ("Tony') just kept stabbing him (Jackson)."

Investigator Pinkard interviewed Roosevelt Burgess inside 2261 Saxon Street #1. Roosevelt Burgess advised he is roommates with Jerry Nixon and the Nixon family. When Jackson was stabbed he was inside the apartment. Roosevelt Burgess confirmed he was a witness to a portion of the incidents from previous night (May 26, 2020). There was an argument between "Tony" and Jennifer Jackson. He didn't know the nature of the argument.

Roosevelt Burgess stated, following the argument, Malik Jackson walked out of apartment #2 and asked "Tony" about cussing his mother (Jennifer Jackson). Malik Jackson entered his vehicle as "Tony" threatened to fight him. "Tony" was seen with a gun and a knife. The handgun was described as small and silver in color. He heard "Tony" threaten the kill several people at the apartment. "Tony" stated, "I'll kill all of you 'M Fer's' that what I'll do." "Tony" walked toward Malik Jackson, while he was sitting in the vehicle, in a threatening manner while carrying the handgun. According to Investigator Pinkard, Roosevelt Burgess would not say any of the words of profanity and would only use "M Fers" when relating what "Tony" said.

During the argument, a black vehicle arrived. "Dunk" (allegedly Jennifer Jackson's nephew) exited the vehicle. Roosevelt Burgess stated "Tony" started threatening "Dunk." "Dunk" proposed if "Tony" wanted to fight, "to take it to the street," put the knife and gun down and fight him. "Tony" walked back to her apartment door, laid the handgun down (still carrying the knife) and walked back to fight "Dunk."

Roosevelt Burgess stated "Dunk" and "Tony" fought in the street. Roosevelt Burgess stated "Tony" tried to go retrieve the handgun, however "Dunk" wouldn't allow it.

Regarding the stabbing incident, Roosevelt Burgess reported: While he was in apartment #1, "they" (unknown) ran inside exclaiming Malik Jackson had just been stabbed. He exited the residence and observed Malik Jackson running across the street where he collapsed and "Tony" running down the street exclaiming, "yeah I cut him! and I cut him good!" <sup>365.171(15)</sup>

Investigator Pinkard's interviews were captured by his body worn camera.

Investigator K. Rowland responded to 2502 Holton Street, Tallahassee, Florida to assist with both investigations. Investigator Rowland interviewed witnesses.

Abigail Jackson was interviewed. Abigail Jackson advised she Malik Jackson's aunt and sister of Jennifer Jackson. Abigail Jackson advised Natosha ("Tony") was obsessed with Jennifer Jackson, "mentally ill, smoked molly and was very dangerous." On May 26, 2020, at about 7:30pm she received a phone call from her son, Vonderrekus Paden, regarding a fight at 2261 Saxon Street. Abigail Jackson was told "Tony" pulled a handgun and threatened to kill everyone. She called TPD and spoke to officers regarding the incident.

On the date of this incident, Abigail Jackson learned of the stabbing (via another call from Vonderrekus Paden) and Jaheim Nixon attempting to defend Malik Jackson. Abigail Jackson responded to the area and went to 2502 Holton Street #B110 out of fear "Tony" was going to harm her family members at this address. This belief was based on the Facebook Live video posted by Natosha "Tony" McDade the night of May 26, 2020 threatening to kill everyone.

It should be noted, Investigator M. Johnson would later interview Abigail Jackson again and she completed a sworn written statement. See his supplemental report.

Investigator Rowland interviewed Jaheim Nixon, who had fled the scene of the stabbing at 2261 Saxon Street and was at 2502 Holton Street. Jaheim Nixon advised: He was in the vehicle with Malik Jackson, Landre "Dre" Lundy and his sisters, Brianna and Ashanti Nixon. Investigator's note: This is the first witness account regarding Landre Lundy being an occupant in the vehicle and witness to the stabbing.

Jaheim Nixon stated "Tony" was dressed in all black, holding a large knife, walking towards the vehicle, opened the driver's door and started stabbing Malik Jackson several times. The knife was described as a large kitchen knife. Jaheim Nixon exited and ran to the driver's side while Malik Jackson was trying to crawl out of the passenger side of the vehicle. Landre Lundy helped Malik Jackson. Jaheim Nixon started to grab "Tony" and fought for control of the knife as "Tony" crawled onto Malik Jackson's back continuing the efforts to stab and injure him. Jaheim Nixon was able to take the knife from "Tony." Now that Jaheim Nixon had the knife, he started stabbing "Tony" multiple times in an effort to stop the attack.

This allowed Malik Jackson time to escape out of the passenger side of the vehicle and run away. Jaheim Nixon pulled "Tony" away from Malik Jackson, out of the vehicle and then to the ground. In response, "Tony" pulled out the small silver handgun. Jaheim Nixon grabbed the handgun and unsuccessfully fought "Tony" for control over the handgun, eventually letting go and running away. Jaheim Nixon and Malik Jackson ran across the street to the secondary scene located at 2260 Saxon Street. "Tony" followed the duo and pointed the handgun at them as they fled. Jaheim Nixon was unsure why "Tony" didn't fire the handgun at them. Malik Jackson collapsed. Jaheim Nixon advised "Tony" fled the area still in possession of the handgun. He stated the knife was "still somewhere by their car," according to Investigator Rowland's supplement.

Jaheim Nixon described the fight which occurred the previous night on May 26, 2020, when "Tony" came to their house on Saxon Street, as background to this stabbing. Jaheim Nixon saw "Tony" with a knife and the same handgun. "Tony" was looking for Jennifer Jackson, but family members were intervening and told "Tony" to leave. The group engaged in a physical altercation with "Tony." TPD officers responded for the incident however, "Tony" was no longer on scene. "Tony" returned later and TPD officers were summoned to the residence a second time, but "Tony" left again prior to their arrival. Jaheim Nixon explained "Tony" had been on Facebook Live, threatening to kill them all.

According to Investigator Rowland's supplement, Landre Lundy provided nearly the same account as Jaheim Nixon. Landre Lundy was sitting in the vehicle at the Saxon Street house. "Tony" then "came from out otta nowhere" and started stabbing Malik Jackson 8 to 12 times. Landre Lundy described the knife as just a blade, no handle. Landre Lundy also advised the knife was left by the vehicle. Landre Lundy and Jaheim Nixon were able to get Malik Jackson out of the passenger side of the car. Jaheim Nixon took the knife and stabbed "Tony" at least once in an attempt to stop the attack. At some point Landre Lundy punched "Tony" to stop the attack.

After getting Malik Jackson out of the vehicle, they ran away from "Tony." Landre Lundy saw "Tony" with a handgun, pointing it at them. Landre Lundy was not sure where "Tony" pulled the gun from, and denied seeing the gun the night before. Landre Lundy, Malik Jackson and Jaheim Nixon ran across the street and 365.171(15) "Tony" left the area on foot. Landre Lundy explained "Tony" had been on Facebook Live, threatening to kill them all.

Investigator Rowland's interviews were captured by his body worn camera.

In an effort to positively identify "Tony" as Natosha McDade, I requested Investigator Pinkard confirm the witnesses had common interactions, resided in the same triplex with and personally knew "Tony." When this was confirmed, they were separately shown a single photograph of Natosha McDade for identification purposes. Jerry Nixon, Ashanti Nixon, Brianna Nixon, Roosevelt Burgess, and Jaheim Nixon all five identified Natosha McDade as "Tony" and the person they witnessed stabbing Malik Jackson. Investigator Pinkard wrote in his supplemental report, "In addition to the five witnesses, there were others who responded to the

location to be with Malik's family, and many of those subjects saw the picture, and stated that was "Tony."

There were several follow up investigative steps which overlapped with the investigation of the incident at Holton Street. The 911 calls and CAD reports were reviewed for these incidents.

Investigators canvassed the area of the Saxon Street primary and secondary crime scenes. Investigator M. Jackson made contact with the Leon County School Safety Office regarding obtaining any video surveillance images from Bond Elementary School capturing portions of this incident. No images were able to be located to assist this investigation. Investigator B. Bascom contacted the Real Time Crime Center with the same results for video images in the area.

Investigator P. Osborn assisted by sending preservation request letters and obtaining search warrants for Facebook for video evidence related to the physical altercation and McDade's Facebook Live event on May 26, 2020.

As part of the follow up investigation, on June 3, 2020, I met with SAO Investigator J. Lee at the law offices of Annabelle Dias located at 521 North Adams Street, Tallahassee, Florida for scheduled interviews with Jennifer Jackson, Bernadette Kelly and Abigail Jackson. The interviews were scheduled with the assistance of the law firm.

Jennifer Jackson was interviewed. The recording was uploaded. She provided some background and gave a statement regarding unreported crimes.

Jennifer Jackson denied there was a relationship between herself and "Tony." They first met when "Tony" moved in next door at 2261 Saxon Street. Jennifer Jackson stated, two days prior to "Tony" killing her son, Malik Jackson, "Tony" was at my apartment (May 25, 2020). She described how "Tony" "laid on me" and Jennifer Jackson wasn't able to say anything because her children were in the house. "Tony" was upset and made statements about "stalking" her. When asked how long "Tony" was stalking her, the reply was "forever."

Jennifer Jackson was concerned about "Tony" having expressed this obsession to her and explained, despite having sexual intercourse in the past with "Tony" it wasn't for a "relationship." Jennifer Jackson described there was no intent to ever "be together" and "Tony" knew of Jennifer's boyfriend. She denied the relationship was even casual and described it as "just sex." Jennifer Jackson described how "Tony" reportedly had a fantasy about them being together and Jennifer Jackson "belonged to her." While describing these circumstances, Jennifer Jackson expressed a statement of desperation and supposed if she had just given in to "Tony's" wishes maybe Malik Jackson would still be alive.

Jennifer Jackson went on to describe the events which transpired the night of May 25, 2020. There were several people who were at her apartment for a gathering. In the group was the father of one of Jennifer Jackson's children. According to Jennifer Jackson, "Tony" kept giving him a hard time, looking at him and

acting strange towards him. Everyone except the children, Jennifer Jackson and "Tony" eventually left. After everyone left, "Tony" was at the residence and produced a handgun. She threatened Jennifer Jackson and held her against her will in the apartment, exerting dominion over her and causing Jennifer Jackson to believe she couldn't leave. Jennifer Jackson explained how afraid she was of the handgun due to having been "shot before." "Tony" held the handgun to Jennifer Jackson's head causing her to fear for her life and made statements, "I'm going to kill you." Jennifer Jackson pleaded for her life and asked "why?" "Tony" pointed the handgun at Jennifer Jackson, repeated the verbal threats, racked the slide and "clicked it" which caused Jennifer Jackson to fear for her life and to believe being shot was imminent. Jennifer Jackson said she was "scared."

This went on through the night for several hours into the early morning hours of May 26, 2020. It was estimated this time frame was between 3AM to 6 AM. At one point "Tony" allowed Jennifer Jackson to go to the bathroom but followed her into the room. "Tony" closed the door, grabbed her from behind around the neck and held the gun to Jennifer's head. "Tony" declared, "I'm about to kill you and I'm about to kill myself, you ready?" Jennifer Jackson replied asking, "Tony, I'm ready. But, why? Why would you want to do this?" "Tony" replied, "Because I'm fucking tired of you playing with me Jen!" When Jennifer Jackson attempted to explain there was no intent for a relationship between them "Tony" was still upset. "Tony" kept Jennifer in the bathroom against her will for between five to ten minutes but, eventually let them return to the living portion of the residence. Jennifer Jackson explained, "Tony" had the handgun the entire time and if it were possible, she would have fled the residence to escape the escalating violence. The children being left alone inside the residence with "Tony" from committing a murder/suicide. This was a common occurrence of Jennifer Jackson being able to calm "Tony" down. There were two separate incidents in the 30 days leading up to this incident when Jennifer Jackson calmed "Tony" down and stopped the destruction of property in apartment # 3.

When questioned about the fight on May 26, 2020, Jennifer Jackson believed "Tony" was inside apartment #3 and refusing to come out when officers were on scene. She was upset over the officers not attempting to enter the residence or arrest "Tony."

Jennifer Jackson expressed belief "Tony" was intent on hurting her. The action of murdering Malik Jackson was an act to hurt Jennifer Jackson in a manner which would be worse than inflicting violence on her person. As evidence, Jennifer Jackson asserted there were no prior arguments between "Tony' and Malik Jackson.

On May 26, 2020, Bernadette Kelly was at the residence. Bernadette Kelly (who is Jennifer Jackson's best friend) was encouraging Jennifer Jackson to not associate with "Tony." Jennifer Jackson explained it was only one sided (on "Tony's" part) and there was no way to stop someone else having feelings.

It was supposed, "Tony" overheard the conversation between Jennifer Jackson and Bernadette Kelly through

the wall between their residences. Jennifer Jackson explained she was very loud and didn't care if "Tony" heard it because she was upset. Unexpectedly, the front door of the residence "bust" open and "Tony" barged into the residence. "Tony" confronted Jennifer Jackson and asked if she had anything to say. "Tony" alleged Jennifer Jackson of having heterosexual relations. Jennifer Jackson defended herself and explained she was free to do whatever she wanted with others in her house. She then instructed "Tony" to leave the house. Malik Jackson heard the commotion and came inside the residence to intervene. He "calmly" intervened and instructed "Tony" to leave the residence. "Tony" got into Malik Jackson's face and wanted to fight. The fight didn't occur immediately. They exited apartment #2, Malik Jackson went back to sit in his vehicle in the driveway (allegedly to smoke cannabis with friends which was his normal daily activity) and Jennifer Jackson supposed "Tony" went into apartment #3. "Tony" came out and confronted Malik Jackson with a handgun. Jennifer Jackson heard "Tony" arguing with Malik Jackson.

Malik Jackson is reported to have made statements he would "die for his mother." "Tony" returned to sit in front of apartment #3 however, there was still ongoing tension between the parties involved. Vonderrekus Paden arrived and questioned "Tony" about the tension and having an argument with Malik Jackson. The question escalated into an argument between Vonderrekus Paden and "Tony." This started a physical fight in the street. Jennifer Jackson attempted to call law enforcement to intervene because "Tony" had a handgun and a knife. This led to the first call for service on May 26, 2020 (TPD 20-83015).

Bernadette Kelly was interviewed. The recording was uploaded. She described being Jennifer Jackson's best friend. She described how she knew "Tony" through Jennifer Jackson and how "Tony" had professed "love" for Jennifer. These feelings were rebuffed by Jennifer Jackson. She confirmed getting a video chat from "Tony" immediately after the stabbing. "Tony" confessed to stabbing Malik Jackson and requested Bernadette Kelly give a message to Jennifer Jackson about the homicide. "Tony" said, "had stabbed Malik and to tell Jen to pick up her motherfucking son from off the ground." This video chat occurred at 10:49 AM on May 27, 2020. Bernadette Kelly recognized "Tony" by face on the video chat and advised "Tony" was walking "fast" during the video chat. Additionally, "Tony" sent Facebook messages to Bernadette Kelly on May 26, 2020 regarding the intent to kill them. The messages were sent at or around 9 PM. It was confirmed the Facebook account/profile for Bernadette Kelly is "Bernadette Kelly." Investigator's note: Although a legal demand has been sent to Facebook it has not returned as of this writing on June 25, 2020 and the video chat and messages can't be confirmed yet on McDade's account/profile.

Bernadette Kelly confirmed being a witness to "Tony" charging into Jennifer Jackson's apartment (Jennifer's account of the event) and the ensuing argument with Malik Jackson when "Tony" approached Malik seated in the vehicle. Bernadette Kelly left believing there was impending violence.

Abigail Jackson was interviewed. This was her third interview. The audio recording was started after the conversation began. The recording was uploaded.

Investigative efforts were successful in obtaining a copy of the Facebook Live video posted by Natosha McDade. Investigator's note: The pending legal demand sent to Facebook has not returned yet as stated above. This investigator reviewed the video. A portion of the video was transcribed by this investigator. Any mistakes are unintentional. The following is not a transcript of the entire video, nor is it intended to document the entirety of the video.

In part, McDade stated the following: "Someone I gave my loyalty, allowed her son and nephews to jump me. Put the gun down Tony. Put the knife down Tony. He's going to give you a straight up fade. That's what the pussies told me. And they pussies, do you know why? 'cause it was five against my one. They feared my wrath. That's why they wanted me armless. And then when the first pussy nigger that drive the black Acura the biggest of them all hit me, I say you hit like a girl. And then when I went to approach to complete the mission that's when the other pussies hit me from the back. A female slash male, but y'all mother fuckers born men and it took five of you to kick and punch and had me on the ground in a fetal position and I came out looking the same way I was before I went into that fetal position, but you know what? Y'all ain't going to look the same when them bullets touch your dome and I'm posting this live warning comes before destruction and I'm telling you five mother fuckers that you're going to die if I ever see your face. You know that same way I seen y'all that brief moment? When I went and geared up? (while putting on a ski mask) hmm? You know when you seen me? And you took off running? (while taking the ski mask off) That was the warning. But it's not a game. Do you see me? Do you see what I'm dressed in? And I'm going to remain in these same clothes until y'all mother fuckers stop breathing. And you know what? I'm going to do this all alone because unlike you pussies I'm a real goon and see the government stashed me away so I wouldn't be like you mother fuckers. Fake. Phony. Weak. Doped the fuck out with an empty brain. So, the same goon I was when I went in for them Haitians is the same goon sitting her right now, telling you bitches without a fear I'm going to kill you all. Jennifer Jackson, pack your bags you no longer have a home at 2261 Saxon Street. And It's not a threat, it's a mother fucking promise, and this is coming from Satan himself. Who you woke up inside of me. Who I was trying to keep asleep and blend in with you bitches out here in the world, you know? (unintelligible) myself crazy trying to blend in with you bitches. Well I ain't blending no more. This is Tony the tiger all alone coming for your blood and after I get through killing you bitches, I'm going to get back on live if I have the opportunity because I will not be going back to prison. Me and the law will have a stand off after I end you bitches lives. Because I'm fed up. I'm sick and tired of trying to be loyal to a pack of shit. So, all those friends of mine that do know me, know that when I say these mother fucking words that's my final decision. It is what it is." Later in the video, McDade stated, "On God, I am killing and going to be killing because I will not go back to federal prison ... "

Additionally, McDade is seen showing the small silver semi-automatic handgun in the video. McDade continued, "I thought this was loaded until last night I was about to kill a bitch and this is what I discovered" (while showing the handgun was empty). McDade stated, "If I had those bullets I wouldn't be on here right now with y'all... I'd be out there canvasing looking for them...."

McDade made statements affirming intent to have an encounter with law enforcement and confirming threatening or pointing the handgun at subjects the night of May 26, 2020. McDade stated, "...When I pulled that pistol out they got their ass in that car, they weren't gangster no more...." and "I swear to God I'm killing them niggas and I make sure the law take me..."

Statements regarding McDade having or using a knife included, "...motherfuckers like put the gun down Tony. I put the gun down, he peeped the knife, I had this knife in my pocket, yo she got a knife, I'm like yeah there's five of you motherfuckers. So, whats up? And then you lie and said it was going to be a straight up fade. But you niggas feared me once you seen that your leader, "LEADER" (McDade used finger air quotes as an emphasis), that you called in his little black afro, all he do is talk big talk PSHH, if you was so big you wouldn't be sleeping on the couch in your auntie two bedroom..."

An autopsy was completed on May 28, 2020 by Dr. Lisa Fannagan, Deputy Chief Medical Examiner. The Medical Examiner report number is 20M-308.

The report indicates the final pathological diagnoses were Jackson sustained a stab wound to his chest, a perforating injury of left ventricle of heart, Hemopericardium (blood in the pericardial sac of the heart) and a left hemothorax (an accumulation of blood within the pleural cavity- the space between the chest wall and lungs), sharp force injuries of the right side of his head, posterior right upper arm and anterior right shoulder with no injuries of major neurovascular structures. There was a superficial incised injury of lateral left upper eyelid. The evidence of injuries are detailed in the Medical Examiner's Report.

The toxicology report indicated the presence of Cannabinoids detected in postmortem blood.

The cause of death was indicated as a stab wound to the chest. Contributory causes were listed as stab wounds of the neck and right arm. The manner of death is listed as homicide.

Due to the pending legal demands, this investigator anticipates evidence will continue to be collected or submitted and details may require another supplemental report be completed. Specifically, the evidence obtained from the Facebook search warrants are likely to be detailed extensively in TPD report 20-83393 to an extent as to not require inclusion in this report. See TPD 20-83393 for additional.

On May 27, 2020, I contacted ASA Chief John Fuchs and provided him a synopsis of this homicide, the witness identifications of Natosha McDade as the perpetrator, some of the physical evidence collected and McDade being deceased. In certain situations, elements beyond law enforcement's control prevent the agency from arresting and formally charging an offender. Based on the investigation completed for this homicide, it is this Investigator's belief Natosha McDade did unlawfully kill a human being, Malik Jackson, by stabbing him with a knife repeatedly causing injury incompatible with life, and the killing was perpetrated from or with a premeditated design or intent to effect the death of Malik Jackson, contrary to Section 782.04(1)(a)1, Florida Statutes.

As such, this case is Closed, Exceptionally Cleared.

On May 27<sup>th</sup>, 2020, patrol officers responded to 2261 Saxon Street, Tallahassee, Florida in reference to a male victim who had been stabbed by a female (later identified as Natosha McDade) suspect last seen wearing all black clothing. The caller stated the suspect's name was "Toni" and she had a bald head. The complainant advised dispatch the suspect was last observed running south bound on Saxon Street from the intersection of Carver Street.

Officers arrived on scene and made contact with the victim identified as Malik Jackson. Jackson had been stabbed multiple times where he would ultimately succumb to those injuries.

On May 28<sup>th</sup>, 2020 Forensics Specialist Rachael Mecklenburg and I were present for the autopsy of the decedent. The autopsy began at 9:30 AM and was performed by medical examiner, Dr. Flannagan. Forensics specialist Mecklenburg the victim's clothing and major case fingerprints. Dr. Flannagan noted the decedent had several puncture wounds that occurred from a sharp object. Dr. Flannagan advised one of the puncture wounds went through the chest plate and into the heart. See Dr. Flannagan's autopsy report for further details.

This concludes my involvement in this case.
